3. MINUTES

Approval of the Minutes of the February 27, 2025, meeting. Edits to the minutes were proposed by a resident regarding item 5c, Speeding and cut through traffic concerns on Foxridge Drive and Simmons Way.

Goddard motioned to accept the minutes with edits.

4. BUSINESS FROM THE FLOOR/GOOD OF THE ORDER

Public comment made by Patrick Terry. He is requesting consideration of 3-way stop signs and crosswalks at the intersection of Riley Street and Teceira Way. The concern is for drivers not stopping on Riley Street. An additional concern he stated is the overflow parking on Teceira Way on the weekends, with children and families crossing Riley Street to Livermore Park.

5. <u>ACTION/DISCUSSION ITEMS</u>

a. Pedestrian Scramble at Oak Avenue and North Lexington Drive/Creekside Drive

Public Comment: Elisha Kampsen (for Erin Howard)

The Traffic Safety Committee did not recommend a Leading Pedestrian Interval (LPI). The Committee recommends exploring options to restrict movement on North Lexington, starting with extending the center median closer to the interstation with bollards and "Do Not Cross" signage. The Committee additionally recommends that the Public Works Department investigate inexpensive tools to force pedestrian movement further down North Lexington.

b. Analysis of midblock crosswalk near the intersection of East Bidwell Street and Market Street

The Traffic Safety Committee recommends that the City consider including a future project at the identified location along East Bidwell Street if or when it is recognized as a priority through future planning documents, such as the Active Transportation Plan (ATP) and/or the Local Roadway Safety Plan (LRSP), or in conjunction with future development of the Central Business District. Additionally, the Committee recommends a feasibility study of pedestrian crossing signage to direct pedestrians to cross at the Glenn Drive and Coloma Steet crosswalks.
