

RESOLUTION NO. 11492

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ACCEPT A SELECTIVE TRAFFIC ENFORCEMENT PROGRAM (STEP) GRANT OFFERED BY THE STATE OF CALIFORNIA OFFICE OF TRAFFIC SAFETY (OTS) IN THE AMOUNT OF \$173,500 TO REDUCE AND MITIGATE THE IMPACTS OF IMPAIRED DRIVING, DISTRACTED DRIVING, SEAT BELT ENFORCEMENT, PURCHASE A POLICE MOTORCYCLE AND APPROPRIATION OF FUNDS IN THE GENERAL GRANTS FUND (FUND 012)

WHEREAS, the City of Folsom Police Department is requesting the City Council authorize the acceptance of a grant titled “Selective Traffic Enforcement Program (STEP)” for the Period of October 1, 2025, through September 30, 2026, from the State of California, Office of Traffic Safety, in the amount of \$173,500; and,

WHEREAS, selective enforcement of the primary causes of collisions are an effective way to deter motorists would speed, drive while under the influence of alcohol and other drugs, drive while distracted, or otherwise drive unsafe, thereby reducing fatal and injury collisions; and,

WHEREAS, the grant monies will be used to reimburse personnel overtime costs associated with selective traffic enforcement and the training of officers in the detection, apprehension and prosecution of impaired drivers; and,

WHEREAS, the grant monies will be used to conduct community outreach programs through educational presentations and campaigns; and,

WHEREAS, the grant monies will be used to purchase a BMW police motorcycle, including communication radios and associated emergency equipment.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Folsom hereby authorizes the acceptance of a grant titled “Selective Traffic Enforcement Program (STEP)” from the State of California, Office of Traffic Safety (OTS), in the amount of \$173,500, which will provide funding to conduct selective traffic enforcement geared at reducing the number of fatal and injury collisions in the City and provide funding one traffic enforcement vehicle. The City Manager or his designee is hereby authorized and empowered to accept and execute in the name of the City of Folsom all necessary contracts, agreements, amendments, and payment requests hereto for the purposes of accepting and fulfilling the requirements of the grant titled “Selective Traffic Enforcement Program (STEP)”, from the State of California, Office of Traffic Safety (OTS), in the amount of \$173,500.”

NOW, THEREFORE, BE IT FURTHER RESOLVED that the City Council of the City of Folsom authorizes the Finance Director to increase revenue estimates and expenditure appropriations by the grant amount of \$173,500 in the General Grants Fund (Fund 012) to be reimbursed by the State of California, Office of Traffic Safety.
