A RESOLUTION AMENDING RESOLUTION NO. 11377 – A RESOLUTION ADOPTING A LIST OF PROJECTS FOR FISCAL YEAR 2025-26 TO BE FUNDED BY SENATE BILL 1: THE ROAD REPAIR AND ACCOUNTABILITY ACT TO INCLUDE PROJECT DETAILS

WHEREAS, Resolution No. 11377 was adopted without inclusion of the specific project details and locations, which are required for full compliance with California Transportation Commission guidelines; and

WHEREAS, the project list remains unchanged from the originally adopted resolution, and an amendment is necessary solely to incorporate the omitted project information;

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017), was passed by the Legislature and signed into law by California Governor Brown in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure that Folsom residents are aware of the projects proposed for funding in their community, and which projects have been completed each Fiscal Year; and

WHEREAS, the City must pass a resolution adopting a list of eligible projects proposed to receive funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the list of projects will include projects that may not be completed in the fiscal year allotted due to available funding; and

WHEREAS, the City will receive an estimated \$2.3 million in RMRA funding from SB 1 in Fiscal Year 2025-26; and

WHEREAS, this is the ninth year in which the City is receiving SB 1 funding that will enable the City to continue essential pavement resurfacing and concrete projects that would not have otherwise been possible without SB 1; and

WHEREAS, the City used a combination of the Pavement Management System and known priorities to develop the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective pavement resurfacing projects that also meet Folsom's priorities for transportation investment; and

WHEREAS, the SB 1 project list and overall investment in Folsom's local streets and roads infrastructure - with a focus on basic maintenance and safety, investing in the complete

streets infrastructure, and using cutting edge technology, materials, and practices — will have significant positive co-benefits citywide; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Folsom approves this Resolution Amending Resolution No. 11377 adopting the list of projects below to be funded in FY 2025-26 by Senate Bill 1: The Road Repair and Accountability Act.
