### **RECOMMENDATION**

Staff requests that the City Council appoint City Council Representatives to Regional Boards/Commissions.

### **BACKGROUND / ISSUE**

In addition to their responsibilities on the City Council, the Mayor and Councilmembers also represent the City of Folsom on a variety of regional commissions, ensuring that Folsom's interests are effectively advocated at the regional level. These various commissions address important issues of regional interest, including transportation, housing, economic development, and environmental sustainability, among others. By participating in these commissions, the Folsom City Council plays an important role in shaping policies and decisions that impact not only the city but also the broader region.

Assignments to these regional bodies have been proposed based on areas of interest and/or expertise of individual Councilmembers, enabling them to bring their perspectives and particular insights to their respective roles. Additionally, the distribution of assignments seeks to equitably allocate responsibilities, including those assignments that include stipend pay, to ensure fairness and balance among Councilmembers. This approach not only promotes effective representation but also leverages the strengths of each Councilmember, further enhancing Folsom's voice in regional matters and reinforcing its commitment to equitable and impactful governance.

## **POLICY/RULE**

California's Political Reform Act requires the disclosure of stipends received by Councilmembers for their service on additional boards, commissions, and agencies beyond their City Council duties. These stipends, which compensate Councilmembers for their time and participation, must be reported to ensure transparency and compliance with state law. The City of Folsom is committed to adhering to these requirements, which serve to promote public accountability and foster trust in local government.

FPPC Form 806 is used to report additional compensation that officials receive when appointing themselves to positions on committees, boards, or commissions of another public agency. This form has been posted online in advance of the January 14, 2025 Council meeting as required by law, and will be posted again following approval by the City Council.
