SUBJECT:	At-Large Appointments to the Arts and Culture Commission, Historic District Commission, Landscaping and Lighting District Advisory Committee, Library Commission, Parks and Recreation Commission, Planning Commission, Traffic Safety Committee, and Utility Commission

RECOMMENDATION

Staff recommends that the City Council make at-large appointments to the Arts and Culture Commission, Historic District Commission, Landscaping and Lighting District Advisory Committee, Library Commission, Parks and Recreation Commission, Planning Commission, Traffic Safety Committee, and Utility Commission.

BACKGROUND

The terms for at-large appointments to the City of Folsom's commissions and committees (with the exception of three at-large appointments to the Historic District Commission) expire in December of even-numbered years.

To ensure a transparent and inclusive process, a Notice of Vacancies/Invitation to Apply was published in the Folsom Telegraph and the City's newsletter, shared through the City's social media channels, and posted on the City's website, as well as posted on bulletin boards at City Hall and the Folsom Public Library. In addition, communication was sent to current commissioners whose terms expired in December 2024, inviting them to apply to be considered for reappointment.

POLICY

<u>Folsom Municipal Code</u> Section 2.35.030 establishes, in part, the first regularly scheduled meeting of the City Council in December of even numbered years as the uniform termination date for all at-large appointments (except the three at-large appointments to the Historic District Commission representing historic preservation, residents of the Historic District, and a business owner within the Sutter Street subarea, which expire in December of odd-numbered years.)

ANALYSIS

Commissions and committees play an important role by providing program review and advising the City Council on a wide range of issues. Most commissions are comprised of seven members: five members appointed directly by each councilmember and two at-large members appointed collectively by the entire City Council. This structure ensures both individual representation from each councilmember and a collaborative selection of at-large members, hopefully promoting a balanced and inclusive approach to local governance.

The City Clerk's office received over 70 applications by the November 14 application deadline. These applications were forwarded to the City Councilmembers in early December for their advance review and consideration.
