CITY MANAGER REPORTS

City Manager Bryan Whitemyer expressed gratitude to the City of Folsom team for their warm welcome and shared that he looks forward to engaging with the community. He commended the Folsom Police Department's Special Investigations Unit for their efforts in Operation Folsom Blues 2.0. He acknowledged the Folsom Fire Department's response to an incident at Folsom Prison and thanked assisting agencies. He also highlighted the Friends of the Folsom Library book sale, Read Across America Day, and the city's search for vendors for the second annual Earth Day celebration.

COUNCIL COMMENTS

Vice Mayor Raithel thanked the Hackathon participants at Folsom's Tech Week and congratulated the team for their See-Click-Fix project.

Councilmember Rohrbough reported meeting with SacRT representatives and security officers at the Historic District light rail station. She noted that SacRT is interested in attending a future City Council meeting to share updates on efforts to address delays and improve safety.

Councilmember Leary spoke about the construction of Habitat for Humanity homes on Persifer Street and the opportunity to meet some of the Habitat homeowners.

Mayor Aquino discussed the Folsom Cordova school board's decision to eliminate interdistrict transfers to Folsom High, affecting a section of American River Canyon currently in the San Juan School District. She suggested hosting a meeting for affected residents and inviting the school district to explain the situation. Assemblyman Hoover is considering legislation to annex that area into Folsom Cordova, and if unsuccessful, the City of Folsom may want to consider seeking a territory transfer through the State Department of Education.
