**CITY MANAGER REPORTS**

Interim City Manager Dan Haverty spoke about the Communications unit and the Police and Fire staff members who are developing a community outreach program to raise awareness of wildfire risks that will be coordinated with the OES and CalFire outreach in May; he spoke about the 988 service for mental health crisis support 24/7, free self-serve sand and sandbag locations, Folsom non-profits can now apply to sell state approved fireworks, and the open house of the Fun Factory and Kindergarten readiness programs. He welcomed four new employees to the City of Folsom: Parks and Recreation Departments' Hanna Perez and Mathew Trefry, Solid Waste Department Brandon Wetklow, and Police Department police officer pre-service Drew Romo; he also spoke about the milestone anniversaries of Parks and Recreation Department Amy Van der Molen who obtained 30 years of service and Police Department Kimberly Lim-Watson, Parks and Recreation Department Cody Bateson, and Public Works Department Billy Hilton who obtained 20 years of service and thanked them all for their service. He also congratulated five Folsom firefighters on their new roles: Assistant Chief Mat Blake, Captain Stephen Anderson, Captain Matt McCarthy, Engineer Tyler Smith, and Engineer Scott Vasquez. Lastly,

he congratulated Finance Department Liz Hanna, who was promoted to Finance Manager. He thanked all the individuals for their service and dedication to the community.

**COUNCIL COMMENTS**

Councilmember Kozlowski had no comments.

Vice Mayor Raithel spoke about the chickens that were mentioned tonight.

Councilmember Rohrbough spoke about a SacRT meeting and thanked Councilmember Kozlowski for his service on that regional board. She also discussed responding to the residents who use SacRT and their feedback.

Councilmember Leary spoke about cleaning up trash with Mayor Aquino along the light rail, appreciated the information regarding the chickens, and wished everyone a great Valentine's Day.
