City Manager Elaine Andersen announced the ribbon cutting ceremony for the SouthEast Connector Expressway, the Police and Fire Department Trunk or Treat event, volunteers needed for the Zoo's Holiday Lights Event and mentioned that the City is accepting applications for appointments to the various commissions and committees.

COUNCIL COMMENTS:

Vice Mayor Rosario Rodriguez announced multiple upcoming events including Palladio Trick or Treating, Powerhouse Ministries Halloween event, Festifall in the Historic District, Twin Lakes Food Bank Gala, Women's Conference hosted by the Chamber of Commerce, Concerts at Zittel Amphitheater, Veterans Day Parade and ice skating in the Historic District. She also announced that HART of Folsom is looking for volunteers for the winter shelter and congratulated Patrick Mummy and the team at Symmetry Health and wished everyone a Happy Diwali holiday. She asked for future City Council discussions regarding ARPA money allocation, sales tax revenue and presentations regarding economic recovery, RHNA allocations, and future discussion regarding TOT for vacation rentals.

Councilmember YK Chalamcherla thanked the Public Works Department for recent road striping and mentioned that he is looking forward to future road roundabouts. Mr. Chalamcherla spoke of the Johnny Cash Trail Art fundraiser he attended as well as the Police Department's open house and Coffee With a Cop event. He commented regarding water usage and asked that information about water usage be in the City newsletter.

Councilmember Mike Kozlowski spoke of Folsom high school football and stated that both high schools are heading to playoffs.

Councilmember Sarah Aquino commented about landscaping looking better in regard to medians on Broadstone Parkway. She spoke of issues with middle school students at the Walmart shopping center and the recent effort to discourage students' disruptive behavior.

Mayor Kerri Howell spoke of the SouthEast Connector ribbon cutting ceremony and gave an update of regional board meetings she has attended. She encouraged everyone to drive safely and announced that the Cappuccino Cruisers is having a Trunk or Treat event.
