

RESOLUTION NO. 11442

A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF FOLSOM AND THE SACRAMENTO REGIONAL TRANSIT DISTRICT REGARDING THE SUSTAINABLE TRANSIT CONNECTIONS TO HEALTH SERVICES PLANNING AND FEASIBILITY STUDY

WHEREAS, in January 2024, the City Council adopted Resolution No. 11155 authorizing City staff, in partnership with the Sacramento Regional Transit District (SacRT), to apply for the Caltrans Fiscal Year 2024/25 Sustainable Transportation Planning Grant Program for a proposed transit planning and feasibility study focused on expanding access to major health services and key destinations in the Folsom Plan Area; and

WHEREAS, in July of 2024, Caltrans conditionally awarded \$218,472 in grant funding, with the City of Folsom serving as the lead applicant and SacRT as a partner agency; and

WHEREAS, the award requires a local match of \$31,528, with SacRT contributing non-reimbursable staff time valued at \$5,720 toward that commitment; and

WHEREAS, in August 2024, the City Council approved Resolution No. 11249 authorizing the City Manager to execute related grant agreements, formally accept the full award, and appropriate funds in the amount of the grant for \$218,472 in the Light Rail Impact Fee Fund (Fund 451); and

WHEREAS, a Restricted Grant Agreement was finalized in October 2024, and a subsequent administrative budget amendment was approved in July 2025 to proceed with project implementation; and

WHEREAS, in accordance with the Caltrans Grant Agreement, SacRT has committed \$5,720 in non-reimbursable staff time toward the project as part of its local match; and

WHEREAS, SacRT has further committed up to \$67,429 in reimbursable grant-supported staff time to assist with the study, encompassing activities such as transit planning, service development, and the preparation and presentation of a Draft Service Plan to its Board of Directors; and

WHEREAS, A Memorandum of Understanding (MOU) between the City and SacRT will outline project responsibilities, affirm SacRT's commitment of \$5,720 in non-reimbursable local match funding, and specify eligible grant reimbursements, including up to \$67,429 to support SacRT's direct involvement in project activities, and

WHEREAS, the agreement will be in a form acceptable to the City Attorney.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Folsom hereby authorizes the City Manager to Execute a Memorandum of Understanding (MOU) with Sacramento Regional Transit District to formalize its non-reimbursable \$5,720 staff contribution local match and allocate up to \$67,429 in grant funding for eligible project-related support.
