#### **CITY MANAGER REPORTS**

City Manager Bryan Whitemyer recognized the City of Folsom staff for their dedication and energy in serving the community. He expressed appreciation for their continued patience as he works through various ongoing documents and initiatives. He provided an update on the federal grant funding secured for bridge maintenance projects and announced the reopening of the Historic Train Depot. He extended his thanks to FHDA Board Member Jerry Berneau and the broader community for their support in making the project a reality.

Mr. Whitemyer also discussed the release of the updated 2025 Fire Hazard Severity Zone maps by the California Office of the State Fire Marshal. He thanked Fire Chief Ken Cusano for his proactive efforts to keep the public informed. He also shared several recent highlights from public safety teams, including firefighters from Engine and Medic 36 assisting with the delivery of a baby boy and rescuing a group of ducklings. He expressed gratitude to the Folsom Police Department for their support and intervention during two recent juvenile-related incidents.

Finally, he previewed several upcoming community events, including the Festival of Eggs, Community Service Day, and the National Prescription Drug Take Back Day.

#### **COUNCIL COMMENTS**

Councilmember Kozlowski had no comments.

Vice Mayor Raithel highlighted several recent activities, including recognizing Eliza Philip from Vista del Lago High School for winning the Rotary District 5180 speech contest. He also shared his experience judging the Folsom High School Architecture program, discussed the Sac Sewer Harvest Water Program grant, and provided an update from the recent Folsom Cordova Unified School District 2x2 meeting.

Councilmember Rohrbough spoke about a citizen tip that led to the Police Department responding to a juvenile house party. She emphasized the importance of community members reporting suspicious activity. She also shared insights from a recent conference she attended in Monterey.
