#### RECOMMENDATION / CITY COUNCIL ACTION

Staff recommends that the City Council pass and adopt Resolution No. 11273 - A Resolution Authorizing the City Manager to Execute an Agreement with Folsom Lake Ford for the Purchase of Five Police Vehicles.

#### BACKGROUND / ISSUE

The Service Delivery Plan adopted by the City Council calls for replacing marked police cars at 75,000 miles. The Police Department is currently utilizing 12 vehicles with mileage exceeding 75,000 miles, 10 of which are marked patrol vehicles. Five Ford police vehicles were ordered from the Folsom Lake Ford in September 2022; however, the production of these vehicles was postponed indefinitely. Folsom Lake Ford contacted the Police Department in February of 2024 to explain the delay and offer these vehicles as 2025 models at the fixed price set in September 2022, with the understanding that manufacturing would begin in the Fall of 2024.

Nationwide, the supply of vehicles is limited, disproportionately affecting SUVs, including vehicles for police service. The Police Department is fortunate that the Ford Motor Company has agreed to the price quoted in September 2022. This quote is part of a State of California contract which ensures the best available price for these vehicles.

#### POLICY / RULE

Section 2.36.080 of the Folsom Municipal Code requires that the City Council award contracts above \$73,209.00.

Section 2.36.170 of the Folsom Municipal Code permits cooperative purchasing agreements for procuring supplies, equipment, service, or construction with one or more public procurement units following an agreement between the participants. Such cooperative purchasing may include but is not limited to, joint or multiparty contracts between public procurement units and open-ended state public procurement unit contracts, which are made available to the City.

#### **ANALYSIS**

Sport Utility Vehicles (SUVs) have become an industry standard for law enforcement since their introduction in 2013. Ford Explorers are proven to be incredibly durable and reliable for the heavy use demands typical of a police patrol vehicle.

This purchase of five Ford Explorer police vehicles will reduce the number of marked patrol vehicles exceeding 75,000 miles to five.

#### FINANCIAL IMPACT

The purchase of police vehicles was anticipated and included in the approved Fiscal Year 2024-25 Police Budget. Sufficient funds are budgeted and available in the General Fund (Fund 010) for the purchase. The purchase agreement for the five Ford police vehicles would be authorized for an amount not to exceed \$330,210. Once these new vehicles go into service, five high-mileage police vehicles will be disposed of following City Policy.
