

RESOLUTION NO. 11460

A RESOLUTION APPROVING THE FORMATION OF A FIRE SERVICES EXPLORATORY COMMITTEE AND APPOINTING TWO MEMBERS OF THE CITY COUNCIL TO SERVE ON THE COMMITTEE

WHEREAS, the City of Folsom provides fire protection and emergency response services to the residents and businesses within its jurisdiction; and

WHEREAS, the Sacramento Metropolitan Fire District (SacMetro Fire) is a neighboring fire agency providing services to multiple communities within the Sacramento region; and

WHEREAS, the City of Folsom and SacMetro Fire share a mutual interest in exploring opportunities for regional collaboration and potential partnership models for fire service delivery; and

WHEREAS, the City Council desires to form a **Fire Services Exploratory Committee** comprised of two members of the Folsom City Council and two members of the SacMetro Fire Board of Directors to evaluate and discuss various fire service partnership options; and

WHEREAS, this committee shall serve in an advisory and fact-finding capacity only and shall provide updates and recommendations, if any, to the full City Council and the SacMetro Fire Board of Directors.

WHEREAS, it is expected staff members from the City of Folsom as well as the SacMetro Fire Department will attend these committee meetings in addition to the two City Council members and the two SacMetro Fire Board members.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Folsom that the formation of an ad hoc committee under Section 2.04(G) of the Folsom Municipal Code, known as the **Fire Services Exploratory Committee**, is hereby approved.

BE IT FURTHER RESOLVED that the Fire Services Exploratory Committee shall not exist for more than one year, and that the membership of said Committee shall be composed of:

- Two members of the Folsom City Council; and
- Two members of the SacMetro Fire Board of Directors.

The following City Councilmembers are hereby appointed to serve on the Fire Services Exploratory Committee:

BE IT FURTHER RESOLVED that the purpose of the Fire Services Exploratory Committee shall be to review and evaluate potential partnership models between the City of Folsom and SacMetro Fire, including but not limited to operational integration, shared services, or contractual arrangements.
