

**RESOLUTION NO. 11454**

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH ARB, INC. FOR \$3,101,298 FROM THE SEWER OPERATING FUND (FUND 530) FOR THE CONSTRUCTION OF THE BASIN 4 SEWER PHASE 1 PROJECT (WW2201) AND APPROPRIATION OF FUNDS**

**WHEREAS**, the City has identified this project as a priority to maintain the integrity and operation of the City’s sanitary sewer system; and

**WHEREAS**, the Basin 4 Sewer Phase 1 Project consists of rehabilitating and replacing approximately 3,200 lineal feet of sanitary sewer pipeline and appurtenances, the rehabilitation and repair of 17 manholes at various locations within the City as well as the replacement of a sewer flow meter at Pump Station No. 2; and

**WHEREAS**, plans and specifications were prepared for this work and publicly advertised for bids on July 16, 2025; and

**WHEREAS**, ARB, Inc. was the lowest responsible and responsive bidder, with an amount of \$2,819,362; and

**WHEREAS**, this project was included in the FY 2025-26 Capital Improvement Plan with a project budget of \$2,840,705; and

**WHEREAS**, an additional appropriation of funds in the amount of \$515,655 is needed for a revised project budget of \$3,356,360 and sufficient funds are available in the Sewer Operating Fund (Fund 530) for this additional appropriation; and

**WHEREAS**, the agreement will be in a form acceptable to the City Attorney;

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Folsom authorizes the City Manager to execute an agreement with ARB, Inc. for the Construction of the Basin 4 Sewer Phase 1 Project (WW2201) for a not-to-exceed amount of \$2,819,362 with the budgeted amount to include a 10% contingency, of \$281,936 for a total of \$3,101,298.

**BE IT FURTHER RESOLVED** that the Finance Director is authorized to appropriate \$515,655 in the Fiscal Year 2025-26 Sewer Operating Fund (Fund 530) for Construction of the Basin 4 Sewer Phase 1 Project (WW2201) for a total project budget of \$3,356,360.
