A RESOLUTION BY COUNCILMEMBERS KIMBERLY JAMES, DABOUZE ANTOINE, HECTOR GUTIERREZ, LATRESA AKINS-WELLS, AND ALLAN MEARS TO APPROVE THE PURCHASE OF A LANDSCAPE FLEET VEHICLE FROM THE CITY'S PUBLIC WORKS DEPARTMENT.

WHEREAS, the City of Forest Park ("City") is a municipal corporation duly organized and existing under the laws of the State of Georgia; and

WHEREAS, the City's Public Works Department ("Department") have recently been conducting the aging vehicle replacement initiative; and

WHEREAS, the Department has determined the purchase of a 2025 NPR Gas Crew Cab Landscape truck ("Vehicle") is needed to enhance the Parks and Recreation Division's operational efficiency and shall replace the older model; and

WHEREAS, the Department requests the approval to the Vehicle from Bellamy Strickland from capital vehicles funding line 301-51-1540-54-2503 in an amount not to exceed seventy-four thousand, and nine dollars and 00/100 cents (\$74,009.00); and

WHEREAS, the approval of the purchase of this Vehicle is necessary to protect the welfare, health, and safety of City citizens.

THEREFORE, THE CITY COUNCIL OF FOREST PARK, GEORGIA HEREBY RESOLVES:

<u>Section 1.</u> *Approval.* The Department's request to purchase a 2025 NPR Gas Crew Cab Landscape truck from Bellamy Strickland in an amount not to exceed seventy-four thousand, and nine dollars and 00/100 cents (\$74,009.00) as presented to the Mayor and City Council on October 7, 2024, is hereby approved.

Section 2. *Public Record.* This document shall be maintained as a public record by the City Clerk ("Clerk") and shall be accessible to the public during all normal business hours of the City.

<u>Section 3.</u> *Authorization of Execution.* The Mayor is hereby authorized to sign all documents necessary to effectuate this Resolution.

<u>Section 4.</u> *Attestation.* The Clerk is authorized to execute, attest to, and seal any documents necessary to effectuate this Resolution, subject to approval as to form by the City Attorney.

<u>Section 5.</u> *Effective Date.* This Resolution shall become effective immediately upon its adoption by the Mayor and City Council of the City of Forest Park as provided in the City Charter.
