

**RESOLUTION NO. 2024-\_\_**

**A RESOLUTION BY COUNCILMEMBERS KIMBERLY JAMES, DABOUZE ANTOINE, HECTOR GUTIERREZ, LATRESA AKINS-WELLS, AND ALLAN MEARS TO APPROVE THE PURCHASE OF A PLAYGROUND SWING SET FOR PERKING PARK FROM THE CITY'S PUBLIC WORKS DEPARTMENT.**

**WHEREAS**, the City of Forest Park ("City") is a municipal corporation duly organized and existing under the laws of the State of Georgia; and

**WHEREAS**, as part of the ongoing efforts to enhance parks throughout the City, the City's Public Works Department ("Department") requests the purchase of a playground swing set ("Equipment") at Perkins Park since this is the only park in the City currently without a swing set; and

**WHEREAS**, the Department requests the approval to purchase the Equipment from the cooperative contract #010521-BUR with Playsouth Playground Creator for total cost not to exceed twenty thousand, eight hundred and sixty-eight dollars and 94/100 cents (\$20,868.94) from the A.R.P.A. budget line item 253-51-4226-54-1300; and

**WHEREAS**, the approval of the purchase of this Equipment is necessary to protect the welfare, health, and safety of City citizens.

**THEREFORE, THE CITY COUNCIL OF FOREST PARK, GEORGIA HEREBY RESOLVES:**

**Section 1. Approval.** The Department's request to purchase a playground swing set from Playsouth Playground Creator for total cost not to exceed twenty thousand, eight hundred and sixty-eight dollars and 94/100 cents (\$20,868.94) as presented to the Mayor and City Council on October 7, 2024, is hereby approved.

**Section 2. Public Record.** This document shall be maintained as a public record by the City Clerk ("Clerk") and shall be accessible to the public during all normal business hours of the City.

**Section 3. Authorization of Execution.** The Mayor is hereby authorized to sign all documents necessary to effectuate this Resolution.

**Section 4. Attestation.** The Clerk is authorized to execute, attest to, and seal any documents necessary to effectuate this Resolution, subject to approval as to form by the City Attorney.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption by the Mayor and City Council of the City of Forest Park as provided in the City Charter.
