A RESOLUTION BY COUNCILMEMBERS KIMBERLY JAMES, DABOUZE ANTOINE, HECTOR GUTIERREZ, LATRESA AKINS-WELLS, AND ALLAN MEARS TO APPROVE THE PURCHASE OF MATERIALS AND LABOR FOR FLOORING REPLACEMENT AT THE LEONARD HARTSFIELD SENIOR COMMUNITY CENTER AT 696 MAIN STREET FROM THE CITY'S RECREATION AND LEISURE SERVICES DEPARTMENT.

WHEREAS, the City of Forest Park ("City") is a municipal corporation duly organized and existing under the laws of the State of Georgia; and

WHEREAS, the City's Recreation and Leisure Services Department ("Department") requests to remove old tiles and carpet and install new floor tiles at the Leonard Hartsfield Senior Community Center at 696 Main Street ("Location"); and

WHEREAS, the Department requests to purchase flooring materials from Home Depot for an amount not to exceed sixteen thousand, three hundred and forty-seven dollars and 20/100 cents (\$16,347.20); and

WHEREAS, the Department requests to purchase the labor necessary for the flooring replacement at the Location from Accurate Property Services for an amount not to exceed twenty-four thousand, one hundred and twenty-one dollars and 14/100 cents (\$24,121.14); and

WHEREAS, the total project cost for the flooring replacement at the Location shall not exceed forty thousand, four hundred and sixty-eight dollars and 34/100 cents (\$40,468.34); and

WHEREAS, the approval of the materials and labor for the flooring replacement at the Location is necessary for the health, safety, and welfare of the citizens of the City.

THEREFORE, THE CITY COUNCIL OF FOREST PARK, GEORGIA HEREBY RESOLVES:

<u>Section 1.</u> *Approval.* The Department's request to purchase flooring materials from Home Depot and flooring labor from Accurate Property Services in a total amount not to exceed forty thousand, four hundred and sixty-eight dollars and 34/100 cents (\$40,468.34) as presented to the Mayor and City Council on October 7, 2024, is hereby approved.

Section 2. *Public Record.* This document shall be maintained as a public record by the City Clerk ("Clerk") and shall be accessible to the public during all normal business hours of the City.

<u>Section 3.</u> *Authorization of Execution.* The Mayor is hereby authorized to sign all documents necessary to effectuate this Resolution.

<u>Section 4.</u> *Attestation.* The Clerk is authorized to execute, attest to, and seal any documents necessary to effectuate this Resolution, subject to approval as to form by the City Attorney.

<u>Section 5.</u> *Effective Date.* This Resolution shall become effective immediately upon its adoption by the Mayor and City Council of the City of Forest Park as provided in the City Charter.
