**RESOLUTION 2024-\_\_\_\_\_**

1           A RESOLUTION BY THE CITY OF FOREST PARK PLANNING COMMISSION TO  
2    RENAME “WHEELER DRIVE” WITHIN THE CITY OF FOREST PARK, GEORGIA; TO  
3    PROVIDE FOR AN EFFECTIVE DATE; AND FOR OTHER LAWFUL PURPOSES.

4           **WHEREAS**, the Planning Commission for the City of Forest Park, Georgia (the  
5    “Commission”) has the primary responsibility to approve or disapprove matters regarding sub-  
6    divisions, commercial property, residential property, and the zoning of parcels of property; and

7           **WHEREAS**, Wheeler Drive (“Wheeler Drive”) is a private road located within the City of  
8    Forest Park, Georgia (the “City”) and is shown in **Exhibit A** attached hereto, and currently does  
9    not show up as an address; and

10          **WHEREAS**, currently a business named Blue Star Studios is right off of Wheeler Drive  
11    and has complained their clients are unable to locate their business due to Wheeler Drive not  
12    showing up as an address; and

13          **WHEREAS**, the Commission deems it to be in the City’s best interest to rename Wheeler  
14    Drive so that the road may show up as an address; and

15          **WHEREAS**, Section 8-7-31(o) of the City of Forest Park’s Code of Ordinances (“Code”)  
16    states street names shall not be used which will duplicate or be confused with the names of existing  
17    streets in the Standard Metropolitan Area of Atlanta and shall be subject to the approval of the  
18    Commission; and

19          **WHEREAS**, the county and City’s Geographic Information System (“GIS”) department  
20    should reflect such change and update the emergency 9-1-1 system of the address change; and

21           **WHEREAS**, the action to be taken herein would benefit the health, safety, and welfare of  
22 the citizens of the City.

23           **BE IT AND IT IS HEREBY RESOLVED BY THE PLANNING COMMISSION OF**  
24 **THE CITY OF FOREST PARK, GEORGIA**, and by the authority thereof:

25           **Section 1.** That Wheeler Drive as referenced in **Exhibit A** is hereby officially renamed to  
26 “Blue Star Way.”

27           **Section 2.** That the renaming of the street is in accordance with Title 8 (“Planning and  
28 Development”), Chapter 7 (“Subdivisions”), Article D (“Design Standards”), Section 8-7-31  
29 (“Streets”).

30           **Section 3.** That the preamble of this Resolution shall be considered to be and is hereby  
31 incorporated by reference as if fully set out herein.

32           **Section 4.** (a) It is hereby declared to be the intention of the Commission that all sections,  
33 paragraphs, sentences, clauses, and phrases of this Resolution are or were, upon their enactment,  
34 believed by the Commission to be fully valid, enforceable, and constitutional.

35           (b) It is hereby declared to be the intention of the Commission that, to the greatest extent  
36 allowed by law, each and every section, paragraph, sentence, clause, or phrase of this Resolution  
37 is severable from every other section, paragraph, sentence, clause, or phrase of this Resolution. It  
38 is hereby further declared to be the intention of the Commission that, to the greatest extent allowed  
39 by law, no section, paragraph, sentence, clause, or phrase of this Resolution is mutually dependent  
40 upon any other section, paragraph, sentence, clause, or phrase of this Resolution.

41           (c) In the event that any phrase, clause, sentence, paragraph or section of this Resolution  
42 shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise unenforceable  
43 by the valid judgment or decree of any court of competent jurisdiction, it is the express intent of

44 the Commission that such invalidity, unconstitutionality or unenforceability shall, to the greatest  
45 extent allowed by law, not render invalid, unconstitutional or otherwise unenforceable any of the  
46 remaining phrases, clauses, sentences, paragraphs or sections of the Resolution and that, to the  
47 greatest extent allowed by law, all remaining phrases, clauses, sentences, paragraphs and sections  
48 of the Resolution shall remain valid, constitutional, enforceable, and of full force and effect.

49 **Section 5.** All resolutions and parts of resolutions in conflict herewith are hereby expressly  
50 repealed.

51 **Section 6.** The effective date of this Resolution shall be the date of adoption unless  
52 otherwise specified herein.
