#### **PRESENTATIONS:**

#### 1. Proclamation presented to William Ross - Legislative

Mayor Butler read the proclamation to be presented to Mr. William Ross and she and the council congratulated him and took photos.

#### PUBLIC COMMENTS: (All Speakers will have 3 Minutes)

There were two (2) Public Comment Speakers:

**Tiffany McDay** – Work with the Post Office and wanted to know if they would partner with the postal police, because they are being robbed at gunpoint. One carrier was robbed in Morrow, GA and the other was here in Forest Park, off Old Dixie. She wants the mail carriers to be safe and would like to know how they can bridge that gap between the postal and city police. On Morrow Road, speed bumps are needed, because people are speeding like they are on 285. There are school buses down there they must stop for, and sometimes they do not stop.

**Carl Evans** – I do not know who is responsible for the placement of the speed bumps, but they are not put in the right place. The one on my street is at the wrong end and the officers have written multiple citations for people running stop signs and for speeding. People are doing double in the residential areas, and nothing is being done. Signs are placed behind things, and you can barely see them, and the bumps that are out there do not have any white markings on them. At night or when it is raining you can barely see it, and the city is going to be held liable if someone tears up their car or has an accident. I do not want to see the city in a lawsuit, because someone gets hurt or killed. We also have a code enforcement problem. You all passed an ordinance about so many people living in one household. They have been told about it but will not investigate it. Code enforcement say if they don't have a lease, they cannot prove that they are living there. There are some places that are having multiple crimes committed at the house, and nothing is being done about it. Trash is hanging out of trash cans and blowing down the street into people's yards, and this can bring rodents. You have people complain about the waste station, but this is no different. Also, I would love for the new police chief to bring back neighborhood watch and the citizens police academy.

**Councilmember James** – Thanks to everyone for coming out. Congratulations to Mr. Ross for your dedicated services to the city. I would like to remind you of my ward meeting, every month on the 3<sup>rd</sup> Thursday, at 696 Main Street. I will have the gentlemen there, that are building the town homes on the back side of Main Street. He will have renderings of what the town homes will look like.

**Councilmember Antoine** – Big shoutout to Dr. Cooper, and his team for the extraordinary work they did last week, for the police chief candidates. Shoutout to Rock Church of Atlanta, every Friday in that corner, you will see a lot of people getting help. They are doing their thing. Thank you to everyone that came out. I pray that council will vote on the Senegal agenda item, because Forest Park is not just local.

**Councilmember Gutierrez** – Mr. Ross, thank you, it is inspiring to see you stay faithful to our city. Thanks to the public comment people, Mr. Evans, we are going to address these things. Speeding is a common problem we have in our city, and we must get better at it. To the postal worker that is scary and thank you for bringing it up. The safety of our postal workers is very important.

The clean-up was postponed because of the rain, but we will be there this Saturday. We have Food Truck Friday this week, so thank you Director Maxwell, for funding these events. There will be an Easter egg hunt, and it is fun just to see the children out there. Shout out to Captain Ghant, and the police department for showing up for the women's panel. It was very inspiring hearing from you and the other panelist.

We have the Spring Festival coming up in collaboration with Unidos Language School, on the 15<sup>th</sup> we are having a Selena Day, and everyone over 55 is invited to the Senior Prom. On the 29<sup>th</sup> we will have a Wellness Festival in collaboration with one of our school board members.

**Councilmember Akins-Wells** - Mr. Ross, I want to thank you and your family for dedicating 55 years to our departments. Tiffany, is it being done at the post office or out random? Dr. Cooper, I think this is something we can check into, communicating with the police department and the postal service, to see what we can do to help.

**Councilmember Akins-Wells** – How many code enforcement officers do we have because I agree with Mr. Evans? The city is looking bad and since the recycling center is closing, it will continue to look bad, because the residents need that. Again, I would like to know how many code enforcement officers do we have and if we need more?

City Manager - We currently have 5 and I would say you do need more.

**Councilmember Akins-Wells** – I agree, I think we should double that and try and include it in our next budget. With speeding, we must have more officers to put more people in the neighborhoods. A while back we used to have officers sitting on certain streets, where people complained about speeding. So, we should have more patrolling in the residential areas.

With Sister City, I am all in favor, and think it is an amazing idea, but I have to make sure the people here are okay first. If we can discuss this at the next budget meeting and maybe bring some of our things back for the residents, then I will feel better supporting this. We are local officials and must take care of things here first.

Forest Park Day and Fun Friday were taken out of the budget, and other things the community enjoyed. We are getting together to host a Forest Park Reunion. It is for anyone that ever went to school here, regardless of when. We

want to bring the community together and not let money stop that. We want the departments to come out and get involved too.

Thank you, officers, and Chief Clemmons, someone made a comment about you. You are amazing and even people in the police department look up to and respect you. When they made the statement the fire department love Chief Clemmons, they are happy, and she is doing an amazing job. We want that type of leadership, and it speaks volume to the type of person you are, and they deserve that.

**Mayor Butler** – Thanked everyone for coming out. I had the opportunity to visit Fountain Elementary School, and they had their class reunion this past Saturday. I learned a lot about Fountain, and the oldest class member was from 1953. I made the statement while there, you never really understand what a community entails until you are in these seats.

They had the old trophies on display that were once thrown away. Someone went and got them out of the trash and pieced them back together. We have been winning championships since the 50's. It was wonderful to see the photos from the PTSA, what an integral role they played at Fountain High School.

The Ladies of Favor had a wax museum on Friday. Just to know how optimistic I feel every time I leave our school is really a great feeling. We have a lot of great students coming through the pipelines. I feel pleased at the generation coming up after us and I think we are going to be in amazing hands.

Councilmember James – I would like to thank the mayor for the State of the City on March 23<sup>rd.</sup> If you did not get an opportunity to see, it was a beautiful address. I want to congratulate you mayor for putting it together, it was a great presentation.
