### **Explanation for Extension Request for 780 Main Street**

Nachae Jones, owner of Jonesy's Place located at 780 Main Street, was approved for the Façade Grant Program in August 2021. Since then, she has run into issues with her contractor and her project plans, which led to the project stalling for several months. In February 2022, Ms. Jones hired a new contractor, who has been working to get her project started and is currently in communication with an engineer to ensure the proposed improvements will be structurally sound.

According to the Grant Acknowledgement Form, recipients have 6 months to start their project once it is approved by the board or they can be removed from the program at the discretion of the Development Authority.

The Economic Development Project Manager is recommending that Ms. Jones be given an additional 3 months to begin her project since she has run into several issues but has always been very communicative about what is going on with her project.
