Through most of our 80 years on this planet, we have lived in urban, suburban and rural areas . . . from a farm to downtown Dayton Ohio. Over the last 53 years we have lived in Oregon in similar environments. Through our almost 60 years of marriage, we have given back . . . through volunteerism, money, and activism. Not just a bit, but a lot.

We are well-read regarding homelessness not just in Oregon but all over the U.S. We are fully aware of the percentage of homeless who have mental health issues, drug problems, crime issues. We know the effects with this combination on communities. We are well aware of the complexity of the issue, the successes, the failures and what is done (pushed through) when there is no apparent answer. I am fully aware of the responsibilities and duties of elected and appointed officials . . . as I served as one.

I know the process of citizen input. I am aware of what happens when citizens speak (emotionally or logically) to deaf ears. I know about the decent/scared folks who put up a logical argument ("we lack compassion and the issue is too complicated for us to understand"). I know what happens when citizens give up. . . . and what happens soon after.

I urge you not to move forward with the Elm Street pods. It will destroy our small town, put our kids and seniors in danger, drive up our taxes, reduce our property values, and further erode our confidence in our government. We already have / are experiencing what happened during COVID when the homeless migrated from the wetlands, through our community and into downtown. It was frightening then, and it still is.

You are an elected official directly responsible for the well-being of your citizens. Turn this issue back to the bureaucrats who are paid to come up with solutions, not to push through a plan just to get it done. This is your city, your county and your responsibility... do what is right for us and the communities.

You are the one in control. Make a decision for Forest Grove residents. Stop the pods at the end of Elm Street.
