1. CALL TO ORDER AND ROLL CALL:

Chair Phil Ruder called the Planning Commission public hearing to order at 7:00 p.m. via Zoom Video Conference.

A. PUBLIC COMMENT PERIOD FOR NON-AGENDA ITEMS: None.

B. DELIBERATION OF CLOSED PUBLIC HEARING:

(1.)File No. 311-22-000003-PLNG – Oregon House Bill HB 2001 Proposed Amendments to the text of the Forest Grove Development Code (Middle Housing Law) and SB 458 (Middle Housing Divisions)

Chairman Phil Ruder opened the closed deliberation hearing at 7:00 p.m. and asked for a brief presentation from Senior Planner, Dan Riordan.

Mr. Riordan provided the Commissioners with a summary of the HB 2001 Proposed Amendments to the text of the Forest Grove Development Code (Middle Housing Law) and SB 458 (Middle Housing Divisions). The Planning Commission is being asked to make a recommendation to the City Council. City Council will adopt an Ordinance to make the Development Code text changes. There are two upcoming Public Hearings with City Council in which File No. 311-22-000003-PLNG will be presented; April 11th and April 25th.

Commissioners deliberated briefly on each section of the text amendment changes and provided feedback to Mr. Riordan. They focused discussion on combining the R-10 and R-7 Zoning Districts, minimum lots sizes and dimensions and allowing detached duplexes. Discussion also included requiring at least three homes in a cottage cluster and modifying the current dwelling diversity standard. Dan Riordan will compile recommendations for presentation to City Council.

Commissioner Sanderson moved a motion to recommend and adopt File No. 311-21-000003-PLNG Oregon House Bill HB 2001 Proposed Amendments to the text of the Forest Grove Development Code (Middle Housing Law) and SB 458 (Middle Housing Divisions) as discussed and agreed upon at the Planning Commission meeting. Commissioner Nakajima seconded the motion.
