ORDINANCE ADOPTING AN UPDATE TO THE 2010 WATER MASTER PLAN AND AMENDING THE FOREST GROVE COMPREHENSIVE PLAN TO ADD THE WATER MASTER PLAN UPDATE AS A COMPREHENSIVE PLAN TECHNICAL APPENDIX; FILE NUMBER 311-22-000006-PLNG

WHEREAS, Oregon Administrative Rule (OAR) Chapter 333-061-0060(5) requires a master plan for every community serving more than 1,000 people and the master plan shall be maintained for the duration of the period to which the master plan applies, and

WHEREAS, a water facility master plan is required for compliance with Oregon Statewide Land Use Planning Goal 11 (Public Facilities); and

WHEREAS, the City of Forest Grove hired Murraysmith to update the 2010 Water Master Plan (Plan Update); and

WHEREAS, the Plan Update was completed to the satisfaction of the City; and

WHEREAS, the recommendations contained in the Plan Update will serve as guidance for water system capital improvements needed to serve anticipated development within the City's water service area; and

WHEREAS, as required by OAR Chapter 660-018-0020, notice of this application was provided to the Oregon Department of Land Conservation and Development more than 35 days prior to the Planning Commission's public hearing on this matter; and

WHEREAS, the Planning Commission held a duly-noticed public hearing on the Plan update on April 18, 2022; and

WHEREAS, the Planning Commission adopted a motion on April 18, 2022, to recommend that City Council adopt an ordinance approving the Plan Update and amending the Forest Grove Comprehensive Plan to add the Plan Update as a technical appendix as shown on Exhibit C; and

WHEREAS, the City Council held duly-noticed public hearings on May 23, 2022, and June 13, 2022, to consider the Plan Update and findings supporting adoption.

NOW, THEREFORE, THE CITY OF FOREST GROVE ORDAINS AS FOLLOWS:

Section 1. The City Council of the City of Forest Grove hereby adopts the Water Master Plan Update, dated May 2022 (Exhibit A).

Section 2. The City Council hereby amends the Forest Grove Comprehensive Plan to include the Plan Update as a Comprehensive Plan technical appendix.

<u>Section 3</u>. The City Council hereby finds that the proposed amendment is consistent with and meets the requirements of Oregon Statewide Land Use Planning Goal 11 (Public Facilities) as shown in Exhibit B, and meets the master plan requirements of OAR 333-061.

<u>Section 4</u>. This ordinance shall be effective 30 days following its enactment by the City Council.
