

ORDINANCE NO. 034, 2026
OF THE COUNCIL OF THE CITY OF FORT COLLINS
APPROPRIATING PRIOR YEAR RESERVES IN GENERAL FUND FOR CULTURAL
DEVELOPMENT AND PROGRAMMING ACTIVITIES, TOURISM PROGRAMMING,
AND CONVENTION AND VISITOR PROGRAM SERVICES

A. Section 25-244 of the City Code requires Lodging Tax revenue to be allocated as follows: 75% for the promotion of convention and visitor activities and 25% for cultural development and programming activities.

B. Lodging Tax revenue was estimated at \$2,540,000 for 2025 and appropriated; however, actual Lodging Tax receipts were greater than projected.

C. At the end of 2025, a total of \$2,568,502 in Lodging Tax revenues had been collected and the unspent portions lapsed into the General Fund Reserves for Lodging Tax programs and activities.

D. Unanticipated Lodging Tax revenue in the amount of \$28,502 held in the General Fund Reserves is to be appropriated for each of the Lodging Tax programs and activities as follows:

Cultural Development and Programming	\$7,125
Tourism Programming	\$1,425
Fort Collins Convention and Visitors Bureau	\$19,952.

E. These additional funds will help support a future Fort Fund grant process, subject to Council approval of those expenditures.

F. This appropriation benefits public health, safety, and welfare of the citizens of Fort Collins and serves the public purpose of promoting visitor activity and cultural development and programming activities.

G. Article V, Section 9 of the City Charter permits the City Council, upon the recommendation of the City Manager, to make supplemental appropriations by ordinance at any time during the fiscal year from such revenues and funds for expenditure as may be available from reserves accumulated in prior years, notwithstanding that such reserves were not previously appropriated.

H. The City Manager has recommended the appropriation described herein and determined that the funds to be appropriated are available and previously unappropriated from the General Fund and that this appropriation will not cause the total amount appropriated in the General Fund to exceed the current estimate of actual and anticipated revenues and all other funds to be received in this Fund during this fiscal year.

In light of the foregoing recitals, which the Council hereby makes and adopts as determinations and findings, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF

FORT COLLINS that there is hereby appropriated from prior year reserves in the General Fund the sum of TWENTY-EIGHT THOUSAND FIVE HUNDRED TWO DOLLARS (\$28,502) to be expended in the General Fund for Cultural Development and Programming Activities, Tourism Programming, and Convention and Visitor Program Services.

Introduced, considered favorably on first reading on April 7, 2026, and approved on second reading for final passage on April 21, 2026.
