At the end of the project, we presented our ideas to the board and actually saw some implemented in the ensuing months. They were small changes, but tangible, positive changes nonetheless.

Since completing my bachelor's over four years ago, I feel as though things are less and less in my control. Between pandemics, violence, war, and climate news, it's easy to feel defeated and to want to give up fighting these large, existential battles. However, I know from personal experience that on a local level, change is possible and there are many good people fighting for it every day. I love living in Fort Collins and have skills and knowledge that can be useful for the city. I have spent several years researching behavioral and environmental economics and would like the chance to do something real and useful for my neighbors with my narrow slice of expertise. While pursuing my master's at the University of Denver, my thesis focused on how behavioral interventions provide a largely untapped, inexpensive avenue to promote pro-environmental behavior, and I believe some of those ideas are worth exploring in Fort Collins. I want to join either the Air Quality Advisory Board or the Natural Resource Advisory Board for the same reasons. I want to educate myself on the current projects the city is engaged in, learn the ins and outs of what is involved in operating a city commission, and hopefully contribute some of my own ideas around promoting pro-social behavior to build a cleaner, more sustainable Fort Collins.

As summers get hotter, wildfires become more frequent, and draught dominates the daily headlines, I think air quality control and natural resource management are both rising the ranks of problem areas facing the city today. I want to join in the efforts to confront these issues directly and believe I have skills that will aid and enhance the city's efforts.

I am interested in both the Natural Resource and Air Quality committees because many of the issues overlap. A lack of water through rainfall leads to a cascade of environmental emergencies which directly affect the livelihood of everyone in Fort Collins. Not only does draught affect local ecosystems and biodiversity, but the

ensuing fires, days when the AQI is well above healthy levels, and destruction of forests, grasslands, and wetlands all make Fort Collins a less desirable place to live. This has immediate negative effects on the local economy, but also makes Northern Colorado less environmentally and economically sustainable in the long run. I believe that at the core of many environmental issues is non-salience or, lack of attention. Research has shown that simply making people aware of issues and of the consequences of their actions compels them to change their behavior. Enough to stop climate change in its tracks? No. But much like my project in Colorado Springs, it's a start.

My apologies for not following the prompt directly, but I believe that civic engagement is at the core of many problems this city, and many others, face. It's an incredibly difficult challenge to overcome, and I certainly do not believe there is a panacea to the problems around natural resource management and air quality control. Nothing the Fort Collins commission does can affect wildfires in California, Nevada, or even the western slope. However, I do believe there is pragmatism in Voltaire's advice to tend to your own garden. Fort Collins can take care of Fort Collins. If the people actually care about the long-term sustainability of the city, it can create a pro-social, virtuous cycle where people feel compelled to care for the city rather than obligated.

On a much more practical note, there are several behavioral interventions that have been shown to promote pro-social behavior at little to no cost. This includes getting people to volunteer, giving money to charitable causes, emitting less carbon, consuming less water, and using less energy during the hottest months of summer. Even a marginal improvement on one of these dimensions would improve the lives of everyone in Fort Collins. There are several ways the city can increase civic engagement and encourage environmental sustainability while working within the ever-present limitations of a city budget. Water management is, without a doubt, the most pressing issue facing the city (and state) today because of the long-term effects on everything else that makes Fort Collins such a great place to live in the first place. An effective strategy in confronting this issue should also have positive effects on

air quality, biodiversity, and economic sustainability.

The three most important issues that come to mind:

COVID 19 Impacts - The pandemic continues to impact communities in several ways. One way we are seeing the impact is changes in the housing and rental market. Housing demand is high and as prices continue to increase that causes more people to rent. The rental market, however, is also becoming increasingly difficult to navigate as landlords increase rent and enforce stricter screening criteria. While we must understand landlords and property managers have their reasons for increasing rent, we must find and advocate for more affordable housing options to ensure members of our community can sustain housing. This leads into another issue facing this board or commission: homelessness. The Northern Colorado Continuum of Care's By Name List of single adults experiencing homelessness far exceeds the housing resources available. This means that single adults will continue to experience homelessness and the longer they go without housing and routine access to medical, mental and behavioral health care, the more intensive supports they will require. We also face challenges with low income families doubling up to afford a roof over their heads.

Strategic Solutions - there has been an influx of funding due to ESG/ESG CV funds, ARPA funds and other COVID relief dollars becoming available since the pandemic. With this influx of funds comes opportunity to address issues related to housing. With my background in public health, I believe in taking the time to plan and design interventions that have long-lasting impacts. We must step back and review how other organizations/agencies in the community are allocating these funds and identify where the gaps exist. We do not want to duplicate efforts.
