Does Council want to reduce the retention period for Flock data?

- 30 days (current retention)
- 21 days
- 14 days
- 7 days
- or any other retention period Council would like to consider

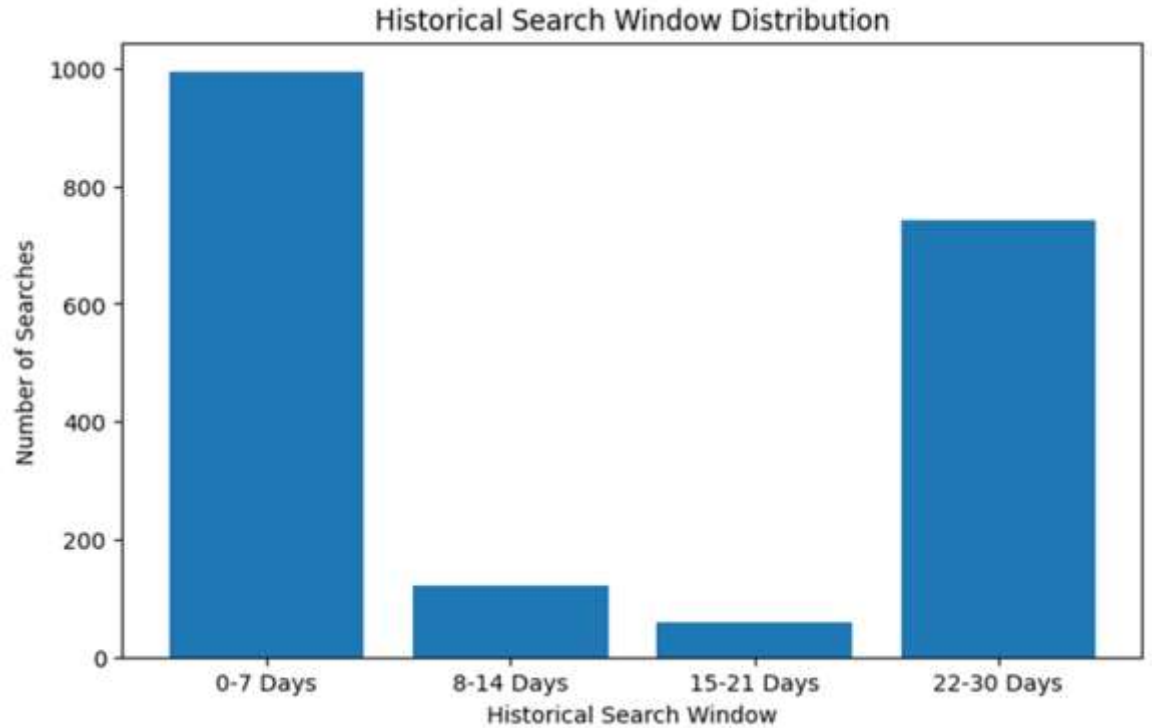
- How long the data is available and accessible in the cloud before it is deleted
- Once deleted, data is permanently removed for all users
- Retention period must be the same for FCPS and all outside agencies
- Set by contract and any changes would require a contract amendment with Flock

- **What impacts Flock search timelines?**
  - Delayed crime reporting
  - Interviews and follow-up
  - Cases develop over time
- **Patrol**
  - Immediate response to crimes in progress
  - Investigations tend to be shorter in duration
- **Detectives**
  - Case assignments is not always immediate
  - Investigations are more complex and develop over time

Lookback Window	Searches	% of Searches
0-7 Days	994	51.8%
8-14 Days	120	6.3%
15-21 Days	58	3.0%
22-30 Days	743	38.7%

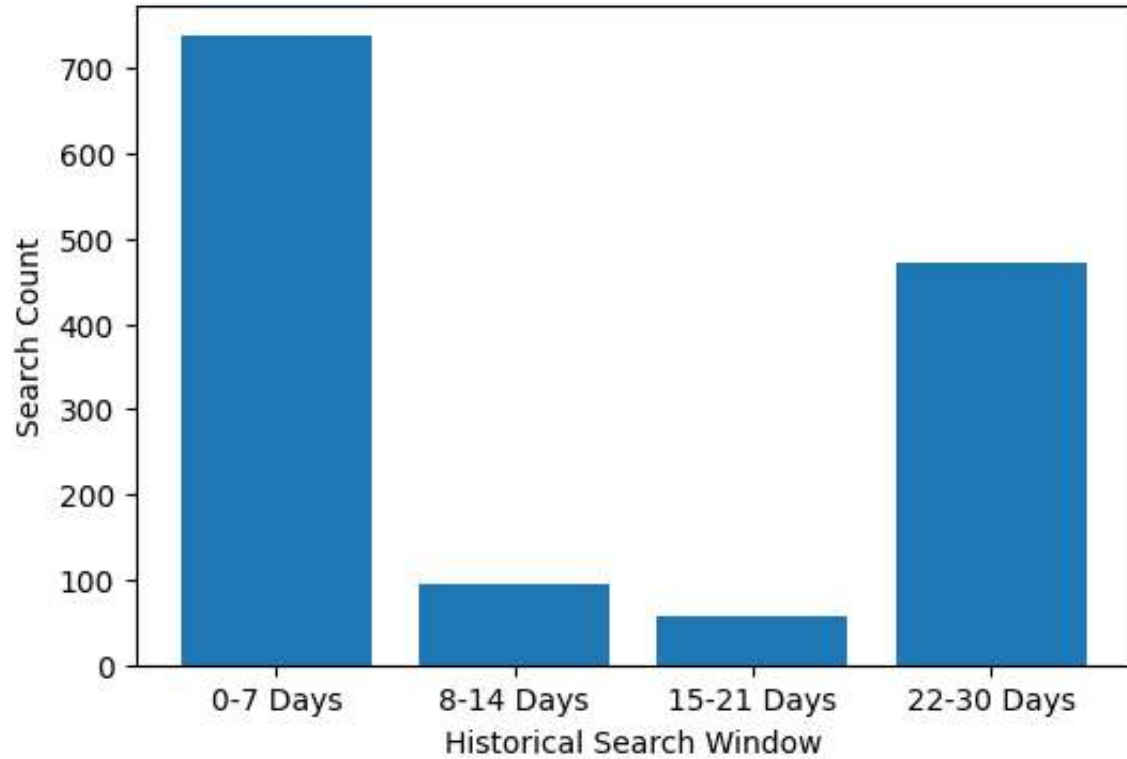
\*Flock searches for April 20-May 20, 2026



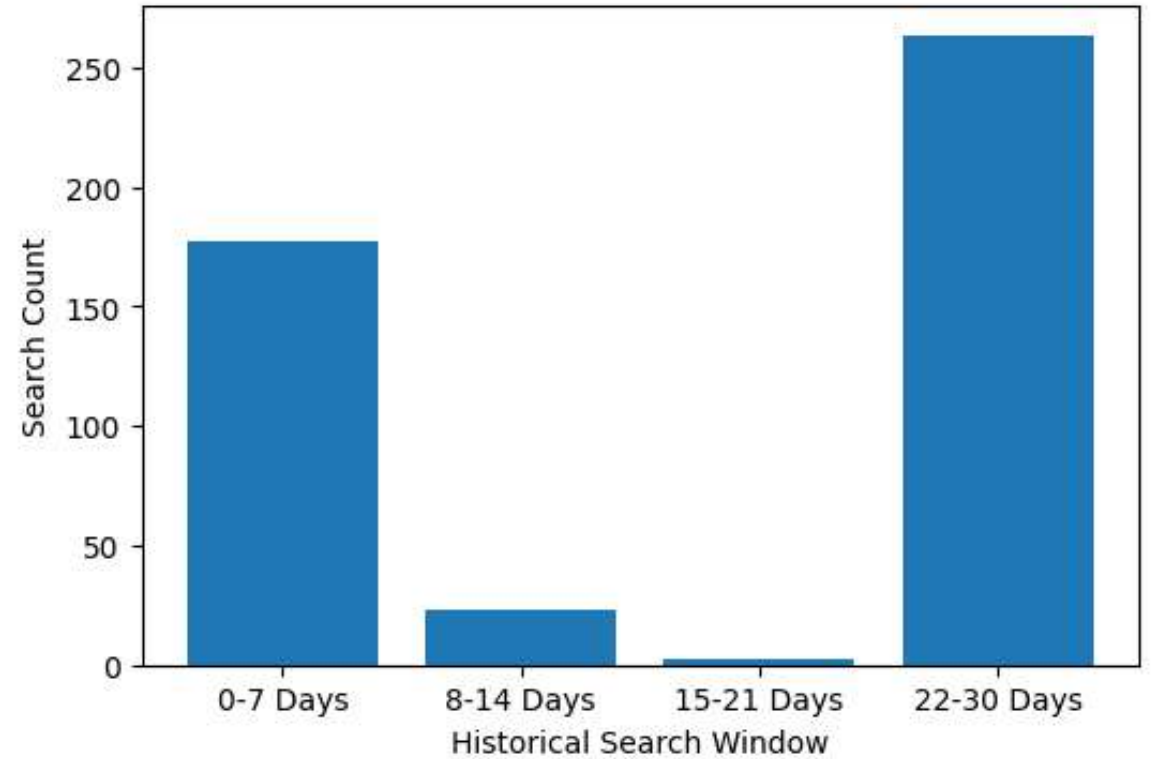
\* The days represent the age of the data searched

- **Does Council want to restrict sharing Flock data with outside agencies?**
- **Considerations for restrictions:**
  - Currently share Flock data with only CO agencies
  - Further limit access by geographic region or specific agencies
- \* Note, FCPS will update their current policy to state that outside agency access will be immediately removed if they share Flock data in violation of:
  - State Law- (e.g. Immigration, Reproductive/ Healthcare purposes), and
  - Other unauthorized searches

1. Which Flock data retention option would Council like to move forward with?

- **Tonight**

- **July 21<sup>st</sup>**
  - Resolution re: CRB and Audit logs/oversight
- **July 28<sup>th</sup>**
  - Council Work Session to review outline of Surveillance Policy
- **Nov-Dec**
  - Draft Surveillance Policy to Council
  - RFP will begin after Surveillance Policy is in place
- **March-April 2027**
  - Target for contract with the selected ALPR vendor
