

NOTICE OF ZONING CHANGE

The Franklin County Board of County Commissioners proposes to adopt the following by ordinance: An Ordinance changing the Zoning on the following parcel of land in Franklin County:

A 10 +/- acre parcel lying in Section 22, Township 6 South, Range 4 West, Carrabelle, Franklin County, Florida, as shown on the attached map, to be changed from A-2 Forestry Agriculture and R-2 Single Family Mobile Home to C-3 Commercial Recreation.

A public hearing on the proposed change to the Zoning Map series will be held on Tuesday, September 1, 2020 at 10:40 a.m., in Courthouse Annex Board Room, 34 Forbes Street, Apalachicola, Florida.
