Reserved Lot West of Lot 16, Block Z, Lanark Beach, Unit 1, Lanark, Franklin County, Florida lying in Section 14, Township 7 South, Range 4 West, Lanark, Franklin County, Florida, as shown on the attached map, to be changed from C-4 Mixed Use Residential to C-3 Commercial Recreation.

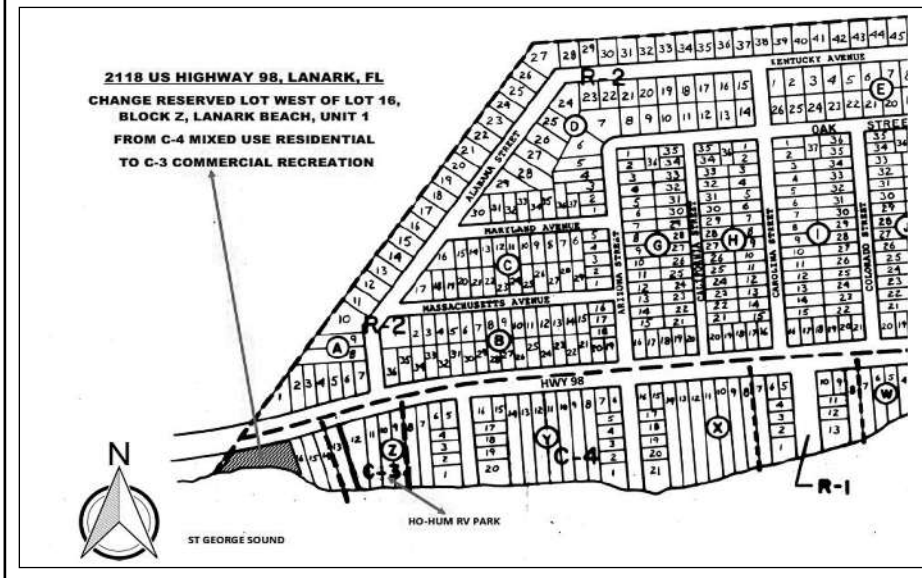
