Property Maintenance

National Inspection Corporation

- Services officially terminate on September 11, 2022
 - Comprehensive, narrative status of outstanding City matters due by August 18th
 - o In person meeting to clarify status of outstanding matters between August 19th and 25th
 - NIC notifies all administrative bodies and courts of law of NIC's withdrawal from representing the City by September 1st
 - o Immediately protect and return all city records by September 11th

Short-Term Plan

- Shifted the new SafeBuilt inspector, Mark Freukes' attention from Point of Sale/Rental Inspection to Property Maintenance to fill the gap.
- Kyle Lovelace was also empowered to assist with Property Maintenance, so we have some backup. However, Kyle is already extremely busy with existing Fire Marshal and Zoning duties. It is not possible to add additional duties to his role at this time.

Point of Discussion

- Expand the role of SafeBuilt within the City.
 - Fees are all inclusive of vehicle, IT, Insurance etc.
 - \circ Half-Time Inspector: 1,040 x \$70 = \$72,800
 - o Full-Time Inspector: $2,080 \times $70 = $145,600$
- Create a new city position.
 - City bears all additional costs (Vehicle, Health Insurance, Retirement, Pension Pick-Up...)
 - Average Salary Range \$46,954 \$63,274 (Excluding Benefits) See Pg. 2.
 - o Civil Service & Classified Position; Start 9-months or more from now.

Recommendation

 Pause POS/Rental Inspection program; Allow SafeBuilt to Manage Property Maintenance in the meantime; Allow us to continue to vet current costs/options.
