Scope/Description: Main Street Tavern of Franklin, LCC, DBA Main Street Tavern of Franklin has submitted a new application to the Division of Liquor Control for a D2, D3 and D3A liquor license.

D-2: Wine and mixed beverages for on premises consumption or in original sealed containers for carryout only until 1:00am.

D-3: Spirituous liquor for on premises consumption only until 1:00am.

D-3A: Extends issued permit privileges until 2:30am. Must at least have D-3 to get the 3A.

Recommendation: Staff has no objections to this application and does not recommend a hearing request.

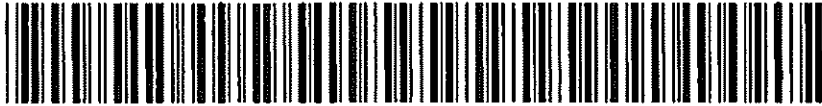
