BACKGROUND

Sales, Use Tax and Lodging Tax Revenues – November 2021 Sales.

The following chart provides a comparison of sales, use and lodging tax revenues between 2020 and 2021. Overall tax revenues are up \$1.15 million from the prior year and ahead of budgeted amounts by \$1.47 million.


Sales tax revenues are up 12% for the month over the same period last year and up 15% year to date. Attached is 5 year history of the year-to-date sales and use tax revenues by Category (NAICS).

Use tax revenues on motor vehicles are up 94% for the month (up 22% for the year) and use tax revenues on building materials are down 42% for the month and down 1% year to date.

Community Center Fund – November 2021.

City sales and use tax revenues for November reflect a 19% increase from 2020 revenues (15% YTD). Sales and use tax revenues collected YTD represent 114% of the 2021 budgeted revenues.

November charges for services (pass fees and recreation programs) are up 155% from the prior year (77% YTD) but down 17% from 2019 pre-covid levels for the month and (23% YTD). However, this compares favorably to the 2021 budgeted revenues which were budgeted at 53% of 2019 pre-covid levels.



<u>Revenue vs Expense by Account Type – PRELIMINARY December 2021.</u> This report presents PRELIMINARY summary information on revenues and expenses and budget comparisons for all funds. The report includes revenues and expenses by type and also by department. The following is a summary of the report by fund showing actual revenues and expenses as a percentage of budget.
