Hi Deb, please see the updated narrative for REXY.

The Beer Garden will run from 2:00pm-10:00pm.

REXY Event Narrative:

REXY is a true desert gravel cycling ride full of incredible beauty, amazing roads, epic climbs, and endless views. A route connecting two of the most iconic towns in off-road cycling via a ribbon of unknown, untapped, unbelievable gravel. Moab - Fruita, Cisco - Fruita and the Border to Fruita, via a route that few even know exists. Full aid stations, marked course, and sag support. Shuttle options to the start of the 200 and 100 mile courses.

Riders will be shuttled to Moab or their corresponding start location and finish in Fruita at Little Salt Wash Park. Riders will start finishing in the afternoon on Saturday, October 7th and will come in all the way through midnight. Post race food is provided and alcohol will be provided to riders within the beer garden as specified on the attached map.

There will only be one point of entry to the beer garden that will be monitored by contracted security staff. Because the finishers will be very spread out and there are less than 500 people competing, we do not envision any crowd control concerns.

The fencing will be a combination of existing fencing between the ball fields and temporary snow fencing with necessary stakes to ensure that the perimeter is clearly marked and able to be monitored by event security. This temporary fencing will be set up Saturday morning to be ready for the beer garden to open.

Portable restrooms are being set up along the course and will be in the parking lot of Little Salt Wash park as well.

"No alcohol beyond this point" signage will be placed at the lone exit of the beer garden area.

Riders have pre registered for this event and anyone under 21 will not be given access to alcohol which is being given out in cans by a volunteer group with all volunteers being over the age of 21. Event organizers will be preparing food on grills for the athletes and all trash/recycling will be managed by volunteers to make sure no waste is left behind.
