

**RESOLUTION 2022-23**

**A RESOLUTION AMENDING THE 2022 BUDGET WITH A  
SUPPLEMENTAL APPROPRIATION OF REVENUES FOR THE  
WELLSPRING PROJECT, TRAIL CONSTRUCTION, BUILDING  
REPAIRS AT THE WASTEWATER TREATMENT FACILITY, AND  
VEHICLE REPAIR AND MAINTENANCE.**

**WHEREAS**, the City has \$3,000 in unspent funds from the Arts and Society Grant that can be reappropriated for the Wellspring Project in 2022, and

**WHEREAS**, the City has received a grant award from the Colorado Tourism Office for new trail construction at the North Fruita Desert Special Recreation Management Area, and

**WHEREAS**, the City has received revenues from an insurance damage award sufficient to cover the cost of repairs to the canvas at the Fruita Wastewater Treatment Facility, and

**WHEREAS**, the City has received revenues from insurance damage awards to repair damages to two vehicles from automobile accidents, and

**WHEREAS**, pursuant to Article 8.10 of the Fruita City Charter, the City Manager certifies there are sufficient funds available for the supplemental appropriations as noted below.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FRUITA, COLORADO AS FOLLOWS:**

**Section 1:** That the 2022 appropriation for the General Fund is hereby increased by \$3,000 from \$16,043,315 to \$16,046,315 from the following sources for the following uses:

**Section 4:** That the 2022 appropriation for the Fleet Maintenance Fund is hereby increased by \$17,250 from \$401,100 to \$410,950 from the following sources for the following uses:
