FUNDING REQUEST SUMMARY

Project Name: Riverfront Trail Project

Amount of Request: (\$) 4,600

Summary of Request:

One Riverfront (ORF) is an advisory commission to Mesa County, City of Grand Junction, Town of Palisade, and the City of Fruita; our mission is preservation, and restoration of the Colorado Riverfront Greenway. We are the working arm of the Colorado Riverfront Foundation (RFF). We work with the RFF as our fiscal sponsor and with neighboring government entities to secure grants. Per Resolution 31-9 (a joint resolution between the City of Grand Junction, the Town of Palisade, the City of Fruita, and Mesa County) each entity will, on an annual basis, budget for the operation of ORF. The City of Fruita is responsible for 6% of the ORF's annual budget.

How does this program/project benefit the citizens/businesses of the City of Fruita? When the Monument View Trail was completed in 2014, it connected the City of Fruita to the City of Grand Junction. Base on past trail-traffic counter reports received from Mesa County, there are 100's of people using the trail on a daily basis whether for recreation or commuting. Adding the Lower Salt Wash Trail connecting to the James M. Robb Colorado River State Park-Fruita Section, trail users can ride along the greenway of the Colorado River. Trail users were



extremely excited with the Kokopelli Trail Connection completion in 2018. They love the ability to ride from Grand Junction to Loma on one continuous trail.

How does this program/project help the City to achieve its goals and priorities (Exhibit A)? Our efforts began in 1987 as a response to years of industry degradation that had severely impaired the Colorado River and the quality of life for Mesa County residents. Our first project was to clean up junk cars and uranium mill tailings from what is now known as Watson Island and Las Colonias Park in downtown Grand Junction. We have continued our primary focus on connecting the various community resources and parks by completing a paved multi-use, recreational trail. Trail users can now access the riverfront trail from downtown Fruita. They can attend the Colorado Riverfront Series and users coming from Grand Junction can get to downtown Fruita. Trail users are visiting area shops, restaurants such as Suds Brothers, Munchies, Hot Tomato, Copper Brewing Club, and Base Camp Provisions not to mention the Community Center/Library, and even the Saturday Farmers Market.

Describe other funding sources and financial support for this project/program, both internally and from other outside agencies, including in-kind contributions such as donated goods or services.

City of Grand Junction - \$17,977-pending; Town of Palisade - \$3,604-pending; Mesa County stopped funding ORF in 2013 but provides ORF office space for \$100 per year. The RFF has stepped up from time to time since 2013 to help cover the budget shortfall.

Will the organization be able to continue to deliver services in the future without City funding? How will the success of this program be measured?

ORF would have to depend on the RFF to provide the annual funding, which means less cash match available to our partners' grant requests.

Summary of Request:

RiversEdge West is requesting \$12,500 from the City of Fruita to support the Grand Valley River Corridor Initiative (RCI). RCI is a planning effort which supports a river corridor that works for all members and values of the Grand Valley community including community access to and use of this vital amenity, agriculture, tourism, development, environment, and health and safety. In 2024 all local jurisdiction signed a support letter to proceed with a master planning exercise. The RCI has identified the Colorado Water Conservation Board (CWCB) Water Plan Grant (due December 1, 2024) to fund this master plan along with ongoing capacity support and floodplain project development from June 2025 to May 2027. RiversEdge West has agreed to submit and manage this grant on behalf of the RCI. This grant requires a match of 25% of which at least 12.5% is cash (the remainder can be in-kind). The Grand Valley RCI is requesting that the local jurisdictions provide a combination of cash (\$88,000) and in-kind staff time (\$10,000) to fulfil this match requirement.

How does this program/project benefit the citizens/businesses of the City of Fruita?

The Grand Valley River Corridor Initiative (RCI) benefits the citizens and businesses of the City of Fruita by providing a collaborative approach to managing the river corridor through the Grand Valley for the benefit of current and future generations. The Colorado River is lifeblood of the community and is a vital economic, cultural, and ecological resource that supports the Grand Valley and associated jurisdiction's well-being and prosperity.

The planning efforts and the coordination provided by the Grand Valley River Corridor Initiative support a river corridor that works for all members and values of the Grand Valley community including community access to and use of this vital amenity, agriculture, tourism, development, environment, and health and safety.

Funding is requested to support the next phase of the RCI, which will include a master planning process, which has been unanimously supported by Mesa County, the City of Grand Junction, the City of Fruita and the Town of Palisade. This process will explore and develop policy frameworks and concept design to support the Master Plan vision and include the evaluation and concept development of recreation, mobility, land use, habitat restoration and floodplain management within the river corridor.

How does this program/project help the City to achieve its goals and priorities (Exhibit A)?

This project helps the City to achieve the following goals and priorities:

Quality of Place: RCI strives to identify priorities and actions for supporting smart, rivercompatible activities so that in the years to come, the quality of these benefits can be maintained and can enhance the economic resilience, health, and safety of the Grand Valley community and its natural landscapes.

Economic Health: The health of the river corridor directly correlates with the health and stability of the economy. As economic growth and development continues in the region,



coupled with chronic and potentially worsening environmental stressors such as drought and fire, it is imperative to have a concerted effort in sustainable planning to ensure that the river corridor is managed to support its diverse values that contribute to the economic vitality of the local community.

Lifestyle: The river corridor offers an abundance of recreational opportunities that are dependent on a sustainable and collaborative management approach across the entire Grand Valley. From sustainable development to conserving important riparian habitat along the river corridor, activities such as rafting, fishing and wildlife viewing can all be supported and enjoyed by Fruita residents and visitors.

Describe other funding sources and financial support for this project/program, both internally and from other outside agencies, including in-kind contributions such as donated goods or services.

RCI has had a variety of funding sources over the years. Since 2020, \$291,000 has been secured through One Riverfront Foundation, Might Arrow, Xcel, Colorado Healthy Rivers Fund, Western Colorado Community Foundation, Colorado Water Conservation Board and the Colorado River District. In-kind support has been contributed consistently since 2020 through the RCI Core Team which includes representatives from RiversEdge West, American Rivers, and Colorado Mesa University. River Network joined as a Core Team member in 2023 and has contributed in-kind and cash match.

The next master planning phase of RCI currently has \$22,500 committed through the RCI Core Team. The City of Grand Junction is currently in the process of approving \$36,500 in cash match and \$2,500 in in-kind match. The Town of Palisade is currently in the process of approving \$2,500 in cash match and \$2,500 in in-kind match. Discussions on match opportunities are still taking place with Mesa County.

A grant request to the Colorado Water Conservation Board will be submitted Dec 1 in the amount of \$305,500 to support the overall master planning phase for the RCI project.

Will the organization be able to continue to deliver services in the future without City funding?

RCI will be able to continue to deliver services in the future without City funding, however for the sustainability and vitality of the initiative, participation from the City of Fruita is strongly encouraged which in turn can provide in-kind match support.



How will the success of this program be measured?

The ongoing commitment and participation of a diverse group of stakeholders, including representatives from each of the jurisdictions of the Grand Valley is a key measure of success. The RCI Advisory Council, which has committed representatives from the City of Fruita, meets quarterly and will hopefully continue to do so well into the future.

More directly, for this next phase of the initiative, completing a comprehensive river corridor master plan that encompasses stakeholder input and has collective buy- in and support will be a measure of success. This in turn can lead to actional steps to enhancing the river corridor and to making collaborative land use decisions that support the shared values of the Grand Valley community.

NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Nature of Activities

Riversedge West (REW) is a 501(c)(3) non-profit organization, incorporated in the state of Colorado in 2002. The purpose of REW is to provide education, technical support, and coordination of activities for the management of tamarisk and other riparian invasive plants and the restoration of riparian lands in the western United States. REW's programs are supported primarily by grants and contributions.

Comparative Financial Information

The financial statements include certain prior year summarized comparative information in total but not by net asset class. Such information does not include sufficient detail to constitute a presentation in conformity with generally accepted accounting principles. Accordingly, such information should be read in conjunction with REW's financial statements for the year ended December 31, 2022, from which the summarized information was derived.

Tama

Cash Equivalents

REW considers all cash and highly liquid financial instruments with original maturities of three months or less, which are neither held for nor restricted by donors for long-term purposes, to be cash and cash equivalents. Cash and highly liquid financial instruments restricted to long-term purposes, if any, are excluded from this definition.

Grants Receivable

Grants receivable consist primarily of the amounts due for program services performed on reimbursement basis. REW reviews grants receivable for collectability and has determined the balances to be all collectible. Therefore, no allowance for doubtful accounts has been provided. Receivables are considered impaired if full principal payments are not received in accordance with the contractual terms. It is REW's policy to charge off uncollectible grants receivable when management determines the receivable will not be collected. Also, REW does not have a policy to charge interest on late payments. All of grants receivable are collectible within year.

Promises to Give

REW records unconditional promises to give that are expected to be collected within one year at net realizable value. Unconditional promises to give expected to be collected in future years are initially recorded at fair value using present value techniques incorporating risk-adjusted discount rates designed to reflect the assumptions market participants would use in pricing the asset. In subsequent years, amortization of the discounts is included in contribution revenue in the statement of activities.

REW reviews receivables for collectability and has determined the balances to be collectible. Therefore, no allowance for doubtful accounts has been provided.

Property and Equipment

Expenditures for equipment are stated at cost. Donated assets are recorded at their estimated fair market values at the date of contribution. If donors stipulate how long the assets must be used, the contributions are recorded as restricted support. In the absence of such stipulations, contributions of property and equipment are recorded as unrestricted support. Depreciation is computed on the straight-line basis over the estimated useful lives (3 to 5 years) of the respective assets.

Improvements that materially add to the value of an asset's life are capitalized. Maintenance and repairs, which neither materially add to the value of an asset nor appreciably prolong its life, are expensed as incurred.

REW capitalizes items over \$2,500.

Investments

Investments in marketable securities and investments in debt securities are valued at their fair value based on quoted prices in active markets (all Level 1 measurements) in the statement of financial position. Unrealized gains and losses are included in the change in net assts.

The only time REW has investments is when REW receives in-kind donations in the form of investments such as stocks and mutual funds. It is REW's policy to sell those investments as soon as it receives them. On rare occasions, REW has some investments received and yet to be sold as of the year end and it would be reported on the statement of financial position on those occasions. As of December 31, 2023, REW had \$0 in investments.

Due to Partner, Confluence Center

The funds received by REW on behalf of Confluence Center of Colorado, Inc (the Center), approximately \$75,000 for the year ended December 31, 2023, are being recorded as increases in liability and any expenses paid on behalf of the Center, approximately \$40,000 for the year ended December 31, 2023, are being recorded as decreases in liability on the statement of financial position since REW lacks discretion to choose the beneficiaries of these funds received.

<u>Net Assets</u>

The financial statements of REW have been prepared in accordance with U.S. generally accepted accounting principles ("US GAAP"), which require REW to report information regarding its financial position and activities according to the following net asset classifications:

Net assets without donor restrictions: Net assets that are not subject to donorimposed restrictions and may be expended for any purpose in performing the primary objectives of the organization. These net assets may be used at the discretion of REW's management and the board of directors.

Net assets with donor restrictions: Net assets subject to stipulations imposed by donors, and grantors. Some donor restrictions are temporary in nature; those restrictions will be met by actions of REW or by the passage of time. Other donor restrictions are perpetual in nature, where by the donor has stipulated the funds be maintained in perpetuity.

Donor restricted contributions are reported as increases in net assets with donor restrictions. When a restriction expires, net assets are reclassified from net assets with donor restrictions to net assets without donor restrictions in the statements of activities.

Revenue and Revenue Recognition

REW recognizes revenue from education program revenue when the programs are delivered. REW records special events revenue equal to the fair value of direct benefits to donors, and contribution revenue for the difference. All attendees of these education programs are required to pay their fees either prior to or on the date of the program, essentially creating an environment where there is no accounts receivable associated with education programs. Accordingly, REW reported no accounts receivable or the related allowance for credit loss as of December 31, 2023. Contract liabilities for education programs are reported as deferred revenue in the accompanying statement of financial position.

REW recognizes contributions when cash, securities or other assets, an unconditional promise to give, or notification of a beneficial interest is received. Conditional promises to give, that is, those with a measurable performance or other barrier, and a right of return, are not recognized until the conditions on which they depend have been substantially met.

Contributed Services and In-Kind Contributions

Contributed services are recognized (at fair value of the services received) if the services received: a) create or enhance non-financial assets; b) require specialized skills that are provided by individuals possessing those skills and would typically need to be purchased if not provided by donation.

Individuals volunteer their time and perform a variety of tasks that assist REW, but these services do not meet the criteria for recognition as contributed services.

Advertising Costs

Advertising costs are expensed as incurred. Advertising expense for the year ended December 31, 2023 was \$1,084.

Functional expenses

The costs of providing program and other activities have been summarized on a functional basis in the statements of activities. Accordingly, certain costs have been

allocated among restoration program and supporting services benefited. Such allocations are determined by management on an equitable basis.

The expenses that are allocated include the following:

Federal Income Tax

REW is exempt from income tax under IRC section 501(c)(3), though it is subject to tax on income unrelated to its exempt purpose, unless that income is otherwise excluded by the Code. REW has processes presently in place to ensure the maintenance of its taxexempt status; to identify and report unrelated income; to determine its filing and tax obligations in jurisdictions for which it has nexus; and to identify and evaluate other matters that may be considered tax positions. REW has determined that there are no material uncertain tax positions that require recognition or disclosure in the financial statements.

<u>Estimates</u>

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Concentration Of Credit Risk

REW is largely dependent on grants as a revenue source. For the year ended December 31, 2023, revenue from two donor accounted for 30% of total revenue. Additionally, as of December 31, 2023 these two grantors accounted for 40% of total grant receivable. 100% of promises to give was from one donor.

REW maintains three bank accounts in Grand Junction, Co. Accounts at the institution are insured by the Federal Deposit Insurance Corporation (FDIC). The organization's cash deposits exceeded the Federal Deposit Insurance Corporation limits at various times during the year ended December 31, 2023.

REW's goal is generally to maintain financial assets to meet 180 days of operating expenses (approximately \$650,000). The Board of Directors has designated \$450,000 as operating reserve and roughly \$300,000 is in short-term CD and A\$150,000 is in money market account. In addition, REW has approximately \$145,000 as an operating reserve that does not require board approval before its use. REW has a \$25,000 line of credit available to meet cash flow needs.

NOTE 3 – LINE OF CREDIT

REW obtained an unsecured line of credit of \$25,000 with a bank on April 6, 2024. There is no maturity date. It provides for short-term borrowing and overdraft protection with variable interest at an initial rate of 8%. The balance on this line of credit was \$0 as of December 31, 2023.

NOTE 4 - DUE TO PARNERS, CONFLUENCE CENTER OF COLORADO, INC

Confluence Center of Colorado, Inc (the Center) is a non-profit corporation formed in Colorado on August 30, 2023. The executive Director of REW and two other executive directors of Grand Junction based non-profits are the members of the Center's board of directors. The Center was created to manage the construction and subsequent management of a building complex in Dos Rios Commercial Real Estate Park located in Grand Junction, Colorado. The total estimated cost of the construction is \$7.5 million. REW and the other non-profit partners will be collaboratively fund raising for the establishment of the Confluence Center. For the year ended December 31, 2023, the executive director of REW has spent approximately 300 hours on the Center project and his time is included in fundraising expense on the statement of activities. REW received some funds as agency transactions on behalf of the Center in 2023. They are reported as liability in the amount of \$32,940 on the statement of financial position as of December 31, 2023.

NOTE 5 – NET ASSETS WITH BOARD DESIGNATIONS

The Board of Directors of REW has designated \$450,000 as an operating reserve which requires the board's approval before it becomes available to be spent. It is included in the net assets without donor restrictions on the statement of financial position.

NOTE 8 – LEASES

Geographic Information System (GIS) is a computer system for capturing, storing, checking and displaying data related to positions of Earth's surface. It is widely used throughout REW by the staff for all of programing. <u>NOTE 11 – RETIREMENT PLAN</u>

REW established a deferred compensation plan (the Plan) during 2006 that is available to permanent, full-time or part-time employees. Employees are eligible to make salary reduction contributions to a tax deferred retirement savings program known as a 403(b)(7) plan. REW will match contributions made by employees up to 7.5% of their earnings. REW made matching contributions of \$28,514 for the year ended December 31, 2023.

Project Name: <u>Fruita Cat Spay / Neuter Voucher Program</u>

Amount of Request: <u>\$6000</u>

Summary of Request:

Support from the City of Fruita for Grand Valley Pets Alive spay / neuter program was again successful in the third year. As of Oct. 1, when we paid our bill at Animal Birth Control, the accounting breaks down as follows:

\$6000 Awarded

\$4771 Paid out = 50 cats, 22 Neuter, 28 Spay / 41 feral, 9 pets \$1229 Available

This translates to 12 - 13 vouchers remaining, depending on the category (male, female, feral or pet). Four have been issued.

Sadly, some recipients let their vouchers expire, which is why we have a few available. Some Fruita Felines were fixed under the WCCF Trutta Fund for Veteran Support, the Colorado Pet Overpopulation Fund, and our general fund.

Partnering with Loma Cat House, Animal Rescue of the Rockies, and WeCARe Transfers, many kittens rescued from colonies in Fruita, were fostered and adopted out. In most cases the partner organization paid for the surgery.

How does this program/project benefit the citizens/businesses of the City of Fruita?

This project would fall under the Quality of Place City goals.

Cats at large, be they pets or feral / abandoned, are often a point of conflict in neighborhoods. By funding spay/neuter of pets, and TNR (trap-neuter-return) of feral/colony cats, we work to reduce these conflicts and provide a better life for cats. Reducing the number of kittens born with no chance of finding a home, is a health and safety issue.

Spay/neuter of cats will help the citizens, often low income, who care about and provide food, water and shelter for colonies. They consider their colonies part of their family.

How does this program/project help the City to achieve its goals and priorities (Exhibit A)?

This program fits under the City's goal of **Quality of Place.**

The flood of kittens born to pets and feral cats is overwhelming local shelters. We can only realize of how much worse it would have been without the spays and neuters that have been done over the years. With warmer winters, there is more time to breed. A cat can have as many as 3 litters in a year, with an average of 6 kittens. There are not enough homes.

Sterilized cats cannot reproduce. Through TNR, we trap, spay or neuter, vaccinate against rabies and return cats to their home (where they were trapped). There is no other place for them to go. If they are feral, they are not adoptable. There is much evidence that elimination of a colony of feral cats / abandoned pets creates a vacuum. This vacuum will be filled by more feral cats. TNR of a managed colony is the best way to reduce population growth, illness, males fighting over mates and other problems. Over time a colony will age out.

The hard work by many volunteers to help the cats from the "Car Barn Colony" was an epic achievement. There are many people in Fruita working to make a difference, GVPA wants to help by continuing to pay for the surgeries and rabies vaccines. Past funding from the City of Fruita has done a lot! Fruita is the only City/Community in Mesa County to take action on the cat overpopulation issue.

Describe other funding sources and financial support for this project/program, both internally and from other outside agencies, including in-kind contributions such as donated goods or services.

GVPA has a General Program that is funded by donations, fundraisers, and grants. It used to pay for spay/neuter countywide, including Fruita. Vouchers for pet cats, dogs & rabbits are for \$60 toward the total cost. They can be combined with PUPS certificates from Mesa County Animal Services paying \$25 towards a neuter, \$35 spay.

GVPA has several monthly donors. We have done well on Colorado Gives Day.

Last year we had a donation of \$5000 from the Fruita Thrift Shop. The Summerlee Foundation granted GVPA \$5000 in 2023. We need to wait 18 months before applying again.

An application for an Animal Assistance Fund grant has been submitted.

Will the organization be able to continue to deliver services in the future without City funding? How will the success of this program be measured?

GVPA has been funding Spay/Neuter in Mesa County since 2014 (chart by year attached). We will continue to do a much as possible as funds allow. At of our last meeting on Sept. 19, we were ahead by 78 surgeries completed from the same period last year.
