

The Fruita Area Chamber of Commerce is requesting to be able to serve beer and wine at the Fruita Civic Center Park during the Fruita Food and Brews event taking place on August 26, 2022.

- 1. Description: The Fruita Area Chamber of Commerce and the Fruita Downtown Advisory Board are partnering on August 26, bringing together food trucks and the Fruita Fourth Friday artists to the Civic Center Park.
- Security: The FACC Board Members, Employees and volunteers will work the event to
 monitor the entrances to the licensed area to make sure that no alcohol enters or exits
 the licensed area. Signs will be posted indicating no alcohol will be allowed into or out of
 the licensed area.
- 3. Crowd Control: The FACC Board Members, employees and volunteers will monitor the consumption of alcohol to prevent any patrons from becoming noticeably intoxicated and stop serving any patron showing effects of intoxication. Fruita Police Department will be notified if any activity escalates beyond control of said people.
- 4. Fencing / Barriers: The FACC will use the fencing they share with the City of Fruita and the Fruita Rotary to create a beer garden at the Fruita Civic Center Park.
- 5. Toilets: The FACC will provide portable restrooms for the duration of the event.
- 6. Signage: Signage will be posted at each entrance and exit indicating no alcohol beyond this point and that ID's will be checked.
- 7. ID's: ID's will be checked by FACC Board Members, employees and volunteers and patrons who are 21 or older will receive a wristband indicating that an ID has been checked for legal consumption age.
- 8. Training: The servers of the event will be trained in the procedures concerning the sale and service of alcoholic beverages.
- 9. Trash: FACC Board Members, employees, and volunteers will monitor the area and pick up empty beverage containers to keep premises clean and neat.
- 10. Food: The FACC has invited 4 different food trucks to participate in this event. Food will be available for purchase from these food trucks.
