APPROVE THE REAPPOINTMENT OF MEL MULDER TO THE PLANNING COMMISSION FOR ANOTHER THREE-TERM TO

**EXPIRE IN AUGUST OF 2024** 

#### **BACKGROUND**

Planning Commission member Mel Mulder's term on the Planning Commission expired in July of 2021, therefore creating a vacancy. The vacancy has been advertised on the City's website and Facebook since June 7, 2021 and staff has not received any other applications.

Pursuant to the City of Fruita's Boards and Commissions Policy established by Resolution 2020-32 and adopted by the City Council on August 4, 2020, term limits shall be two consecutive terms for all boards (with the exception of the Board of Adjustments) for all appointments made after August 1, 2020. Mr. Mulder has been made aware of this provision in the policy.

Mayor Kincaid and Board Liaison Councilor O'Brien both recommend the reappointment of Mr. Mulder to the Planning Commission for another three-year term to expire in August of 2024.

If Mel Mulder is reappointed, there will be no remaining vacancies on the Planning Commission.

1. Reappoint Mel Mulder to the Planning Commission for another three-year term to


expire in August of 2024
