AGENDA TEXT: PROCLAMATIONS – Annual Review of Proclamations approved for issuance

BACKGROUND

The Fruita City Council adopted Resolution 2020-44 establishing a policy on the issuance of Proclamations on November 17, 2020. A copy of the policy is attached. The Fruita City Council makes the final determination on whether a proclamation will be issued and reserves the right to edit any drafted material for final wording.

The purpose of this agenda item is for the Council to provide direction to staff on which proclamations that have been issued in the past do NOT need to be reviewed prior to issuance at a future City Council meeting. Requests for proclamations not previously issued by the City Council will continue to be brought before the City Council for review. Please note that these proclamations will not automatically be issued but still must be requested by interested parties by contacting the City Clerk's office or filling out the Proclamation Request form on the City's website.
