BACKGROUND

Marian Heesaker's term on the Arts and Culture Board expires in August of 2021. On July 7, 2021, she submitted her application for reappointment to the Board, which is attached.

The vacancy was advertised on the City's website at fruita.org and on the City's Facebook page between June 1, 2021 and July 9, 2021. Staff received no other applications for this vacant seat. After her application was emailed to Mayor Kincaid and Council Liaison to the Arts & Culture Board Kyle Harvey, both recommend her reappointment to the board for another three-year term to expire in August of 2024.

If Marian Heesaker is reappointed, there will be no remaining vacancies on the board. Ms. Heesaker was made aware that she will only be permitted to apply for one more consecutive three-year reappointment pursuant to the City's Boards and Commissions Policy that was adopted by the City Council on August 4, 2020.
