RENEWAL OF A HOTEL & RESTAURANT - MALT, VINOUS AND SPIRITUOUS LIQUOR LICENSE FOR DRAGON TREASURE

LOCATED AT 576 KOKOPELLI BLVD.

#### **BACKGROUND**

The Hotel/Restaurant Liquor License for the Dragon Treasure Chinese Restaurant, located at 576 Kokopelli Blvd. is up for renewal. Their current license expires on **August 21, 2021.** 

The Police Department report indicates there has been nothing of concern that would hinder the renewal. There are no current TIPS certificates on file in the City Clerk's Office.

The following information is provided as background on the liquor license renewal process:

The licensing authority may refuse to renew any license for good cause, subject to judicial review. This item is placed on the agenda for the Council to determine if there is any cause for a hearing to be held on the renewal of the liquor license. If there is no cause for a hearing, the City Council should approve the renewal of the existing license. If there is cause for a hearing, the City Council should set a date to hold a quasi-judicial hearing to determine if there are sufficient grounds for suspension or revocation of the liquor license. The City Council may also temporarily suspend any license, without notice, pending any prosecution, investigation or public hearing. No such suspension shall be for a period of more than 15 days.

#### FISCAL IMPACT

#### APPLICABILITY TO CITY GOALS AND OBJECTIVES

The City of Fruita is charged with protection of the public health, safety and welfare. The review and renewal of liquor licenses ensures that licensed establishments are operating by the rules and regulations adopted by the City and State concerning the sale or service of beer and alcoholic beverages.

## **OPTIONS AVAILABLE TO THE COUNCIL**

- Renew the Hotel/Restaurant Liquor License
- Schedule a hearing date to determine if there is good cause for the license to be suspended or revoked.
