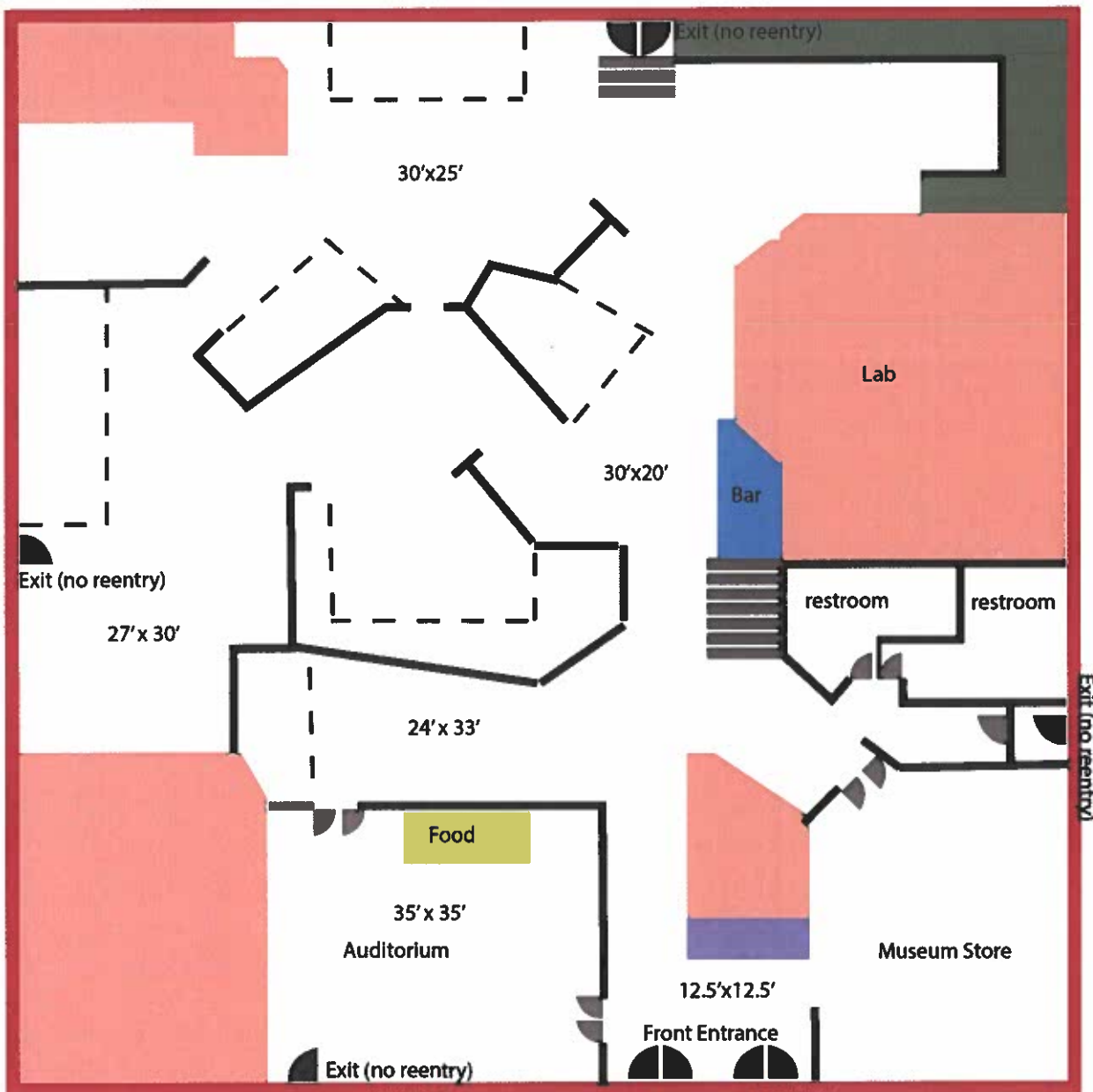

## **Dinosaur Journey After Dark Liquor Permit Narrative**

This is an outreach and mission related event for Museums of Western Colorado. This is a 21+ after hours event created to reach the young professional demographic and engage them in the museums mission "inspires and connects our community by championing the scientific and cultural heritage of the Colorado Plateau." Food and drinks will be served while attendees engage with the exhibits as well as activities built for the evenings theme. Activities will be hands on educational programs to learn more about the paleontology of our area. Appetizers and small bites will be provided at the event as well as nonalcoholic beverage options.

The event will take place inside Dinosaur Journey and will not be outside the building. A single entrance point will be used, all other doors will be exits only and not allow entry. At the entry point, staff members will be checking ids and giving wrist bands to participants. All Museums Staff involved in this event are 21 years of age or older. Only 21+ adults are allowed at this event, and this will be marketed and clearly stated when tickets are purchased. Dinosaur Journey will be closed to anyone who has not purchased a ticket to attend this event and the event will be held outside our normal business hours. Signage will be posted indicating that Dinosaur Journey After Dark is taking place on the front doors of the business. Dinosaur journey has restroom facilities with multiple stalls for each restroom located near the gift shop. The facility will be cleaned by staff after the event.

Alcohol will be provided by Copper Club Brewery and will be served from the area defined on the diagram. Bartenders will be provided by Copper Club Brewery and come with training and experience from their facility. Bartenders will be checking that all participants have wristbands. Bartenders and staff will be monitoring behavior and ensuring that excessive consumption does not occur at the event.

Only people over 21 will be in attendance, IDs will be checked at door. At entrance, all patrons will have ID checked and given a wristband to identify they are over 21.

Alcohol will be served behind a bar area; bar has short wall separating it from the open space. Room behind the bar has refrigerator and storage space that can be locked from participants to separate alcohol from the patrons visiting.
