**RE:** BOARDS AND COMMISSIONS REAPPOINTMENT – A REQUEST TO APPROVE THE REAPPOINTMENT OF CULLEN PURSER TO THE BOARD OF ADJUSTMENT FOR ANOTHER THREE-YEAR TERM TO EXPIRE IN JULY OF 2024

### **BACKGROUND**

Cullen Purser's term on the Board of Adjustments expired in April of 2021. On June 16, 2021, he submitted his application for reappointment to the Board, which is attached.

The vacancy was advertised along with one other vacant seat on the City's website at [fruita.org](http://fruita.org) and on the City's Facebook page between January 1 and July 6, 2021. Staff received one application from Cullen Purser for reappointment and his application was emailed to Mayor Kincaid and Council Liaison Ken Kreie. Both recommend the reappointment of Cullen Purser to the Board of Adjustment for another three-year term to expire in July of 2024. If Mr. Purser is reappointed, there will be one remaining vacancy on the board.

It is worth noting that the Board of Adjustments is exempt from the term limits that are specified in the City's Boards and Commissions Policy that was adopted by the City Council on August 4, 2020.

objectives. They provide a link between citizens of Fruita and city government.

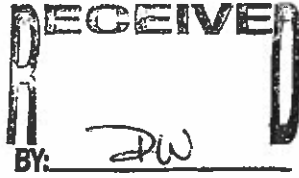
### **OPTIONS AVAILABLE TO THE COUNCIL**


