**RE: BOARDS AND COMMISSIONS REAPPOINTMENT – A REQUEST TO APPROVE THE REAPPOINTMENT OF SONDRA TALLON TO THE POLICE COMMISSION FOR ANOTHER THREE-YEAR TERM TO EXPIRE IN JULY OF 2024**

### **BACKGROUND**

Sondra Tallon's term on the Police Commission will expire in August of 2021. On June 21, 2021, she submitted her application for reappointment, which is attached.

The vacancy was advertised on the City's website at [fruta.org](http://fruta.org) and on the City's Facebook page between May 18 and July 6, 2021.

Staff had one application on file for a previous vacancy from an applicant that was interviewed by Mayor Kincaid and Councilor Leonhart on May 24, 2021; however, both Mayor Kincaid and Councilor Leonhart recommend the reappointment of Sondra Tallon to the Police Commission for another three-year term to expire in July of 2024.

If Ms. Tallon is reappointed, there will be no remaining vacancies on the board and Sondra is aware that she will only be permitted to apply for one more consecutive three-year reappointment pursuant to the City's Boards and Commissions Policy.

Boards and Commissions provide valuable input to the City and help establish goals and objectives. They provide a link between citizens of Fruita and city government.

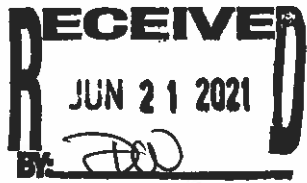
### **OPTIONS AVAILABLE TO THE COUNCIL**
