Cups for a Cure hosted by Fruita Area Chamber of Commerce

Narrative for Special Events Liquor Permit

The Fruita Area Chamber of Commerce is applying for a Special Events Liquor Permit for Saturday, October, 28th 2023.

Cups for a Cure will take place on Saturday, October 28th in Civic Center Park on Aspen Street. Participating vendors will be provided with measurements to set up tables and tents, along with outdoor seating for customers. The type of alcohol that will be served at this event is beer and wine. Alcohol will be served by trained staff within the designated outdoor seating area.

Fencing will be used to block off the marked area for the event. Signage will be posted throughout the area and at all entrances and exits stating that alcohol is not allowed to leave the fenced area and no outside alcohol may be brought in. Staff, board members, and volunteers of the Fruita Chamber will monitor the entrance points to ensure no alcohol enters or exits the licensed area. Signage concerning the consumption of alcohol will be placed at all entrances and exits within the licensed area.

Identification and age verification procedures for the purchase and consumption of alcohol will be processed by staff, board members, and volunteers of the Fruita Chamber. All persons serving alcohol and checking IDs will be 21 years of age or older. Servers of alcohol will be volunteers or hired employees and will be trained in the procedures concerning the sale and service of alcoholic beverages.

Food will be available to patrons in the licensed area through participating restaurants and invited food truck vendors. Food vendors will be placed inside the fenced area.

Restroom facilities will be portable and rented by the Fruita Chamber of Commerce. Staff, board members, and volunteers of the Fruita Chamber of Commerce will collect trash during the tear down of the event and place it in the appropriate location.
