Fruita Civic Center Park – 325 E Aspen Ave

Fruita Circle Park – 125 W Aspen Ave

1) Description:

Civic Center Park: The Fruita Fall Fest is an annual event in Fruita Colorado. It has been a celebration of the fall harvest for over 100 years. Today's event has a parade, outhouse race, music, contests and vendors of all sorts for crafts, artwork, and food. The Fruita Rotary Club, a local non-profit service club, has been providing a beer garden successfully and without incident for many years for festival goers.

2) Circle Park: The Fruita Chamber of Commerce is hosting the last Farmers Market of the year as well as a Cornhole Tournament, if space allows, and Fruita Rotary Club has been asked to provide beer service for the event from 10:30 am to 3:30 pm, or until event is over – whichever comes first.

3) Security: Rotary Club members will provide security along with minimal paid security during daytime hours while the beer garden is open. Beginning at 5:00 pm additional paid security will be on hand to monitor the crowd and beer garden entrances. Signs will be posted at entrances/exits and along perimeter indicating no alcohol into or out of the area.

4) Crowd Control: Rotarians will monitor patrons and the consumption of alcohol to prevent any patrons from becoming intoxicated and stop serving anyone who appears to be intoxicated. Most Fruita Rotarians have been TIPS trained. Paid security personnel will monitor the premises during open hours, with added security in evening hours after 5:00 pm.

5) Fence/Barriers:

Civic Center Park: Metal fencing will be provided by Fruita Chamber of Commerce to enclose Civic Center Park. Entrances/Exits will be monitored by paid security. The beer serving area will be within the fenced area.

Circle Park: The beer serving area at Circle Park will be enclosed by 4' plastic safety fencing and supported by 4' posts every 10'. This event is very low key with patrons perusing the market stands while enjoying a beer. The orange plastic safety fence will provide an adequate barrier defining the licensed area perimeter.

6) Porta Potties: Porta potties will be located outside the licensed premise North of Civic Center building at Civic Center Park and nearby Civic Center Park


7) Signage: Signs will be posted at each entrance/exit indicating no alcohol allowed into or out of the licensed premise.

8) ID's: ID's will be checked by Fruita Rotary members and issued a wristband indicating that their ID has been checked for legal consumption age.



- 11) Food: Food vendors will be available within or nearby the licensed area during hours of operation.

Fall Fest Beer Garden Map




Circle Park
