**AGENDA TEXT:** SPECIAL EVENT LIQUOR PERMIT APPLICATION – A request to approve a Special Event Liquor Permit application from the Fruita Rotary Club to sell and serve beer at Fruita Fall Festival on Saturday, September 24, 2022 from 10:00 a.m. to 10:00 p.m. at Civic Center Memorial Park located at 325 E. Aspen Ave. and Circle Park located at 125 W. Aspen Ave.

**BACKGROUND**

The Fruita Rotary Club has filed an application for Special Events Permits to sell and serve beer during the 2022 Fruita Fall Festival on the date and time noted above at Civic Center Memorial Park and Circle Park in Fruita. State law allows nonprofit organizations to apply for a special events liquor permit, and the Fruita City Council adopted Resolution 2011-32, which authorizes the Local Licensing Authority to issue Special Events Permits to qualifying organizations and political candidates without sending the application to the State Authority for approval.

The City of Fruita requires that the applicant submit a narrative addressing specific issues related to the Special Event Liquor Permit, as well as a diagram(s) of the licensed premises to show the area(s) of control in which alcohol may be sold or consumed and should be strictly adhered to. Staff would like to point out that as it has in years past, this event is likely to draw a bigger crowd of patrons than some of the other events held in Fruita, so the Rotary Club stated in their narrative that they will have additional security in the evening hours after 5:00 p.m.

The application, narrative, diagrams, Fruita Police Department comments and the Rotary Club's Certificate of Liability Insurance are attached.

**APPLICABILITY TO CITY GOALS AND OBJECTIVES**

The City of Fruita is charged with protection of the public health, safety and welfare. The review and issuance of Special Event Liquor Permits ensures that licensed entities are operating by the rules and regulations adopted by the City and State concerning the sale or service of beer and alcoholic beverages.

## **OPTIONS AVAILABLE TO THE COUNCIL**

1. Approve the Special Event Liquor Permit application by the Fruita Rotary Club to serve and sell beer at the 2022 Fruita Fall Festival subject to the following conditions:
  - a) The Rotary Club will discontinue serving alcohol at 9:30 p.m. on Friday, September 23, 2022 to allow patrons 30 minutes to finish their beverages and leave the licensed area and alcohol will be secured and removed by 10:00 p.m.
  - b) Volunteers, board members, employees and hired security will monitor the entrances to the licensed area to make sure no alcohol comes into or leaves the licensed area.
  - c) All other procedures proposed by the Fruita Rotary Club will be followed.
  - d) The Fruita Rotary Club will be solely responsible for the enforcement of state and local liquor laws.
2. Approval of the Special Event Liquor Permit application with amendments to the above conditions.
3. Deny the Special Event Liquor Permit application by the Fruita Rotary Club to serve and sell beer at the 2022 Fruita Fall Festival

## **RECOMMENDATION:**
