RE: SPECIAL EVENT LIQUOR PERMIT APPLICATION – A REQUEST TO APPROVE A SPECIAL EVENT LIQUOR APPLICATION FOR COMMUNITY HOSPITAL – COLORADO WEST HEALTHCARE SYSTEM TO SELL BEER AT CIVIC CENTER MEMORIAL PARK FOR THE RADIATION ONCOLOGY FUNDRAISING EVENT ON SATURDAY, OCTOBER 2, 2021 FROM 12:00 PM TO 8:30 PM

#### BACKGROUND

In order to sell alcohol at community events, State law requires that a not-for-profit or current liquor license holder apply for a special events liquor permit, the applicant is required to uphold the standards and requirements placed on them by the City.

The applicant, Community Hospital – Colorado West Healthcare System, is requesting to sell beer at Civic Center Memorial Park from 12:00 to 8:30 p.m. on Saturday, October 2, 2021 for a fundraising event with all proceeds going directly to cancer patients.

The applicant has submitted all the necessary paperwork to apply for a Special Events Liquor Permit including a Special Event Permit Narrative that outlines the plan for the control of alcohol on the licensed premises. IDs will be checked and attendees will receive a wristband to indicate they are over 21 and can purchase alcohol. The narrative states that there will always be a person who is at least 21 years of age present to ensure no alcohol enters or leaves the licensed area. Signage will also be posted at entrances and throughout the venue indicating that no alcohol can enter or leave the licensed premises.

The Fruita Police Department states in a memorandum that they have no concerns with issuance of the license.

The Special Event Application, Narrative, diagram of the Beer Garden, Parks & Trails Permit form and Police Department's comments are attached.

#### **OPTIONS AVAILABLE TO THE COUNCIL:**

- 1. APPROVE THE APPLICATION FOR A SPECIAL EVENT PERMIT FOR COMMUNITY HOSPITAL – COLORADO WEST HEALTHCARE SYSTEM TO SELL BEER AT CIVIC CENTER MEMORIAL PARK FOR THE RADIATION ONCOLOGY FUNDRAISING EVENT ON SATURDAY, OCTOBER 2, 2021 FROM 12:00 TO 8:30 PM SUBJECT TO THE FOLLOWING CONDITIONS:
  - a) THE ENTRANCE AND EXIT SHALL BE MONITORED CLOSELY AND CONTINUOUSLY BY EVENT STAFF IN ORDER TO PREVENT ALCOHOLIC BEVERAGES FROM GOING INTO OR OUT OF THE AREA.
  - b) THE LICENSEE NEEDS TO BE AWARE THAT THEY ARE SOLELY RESPONSIBLE FOR CONTROL OF THE LICENSED PREMISES IN REGARD TO ALCOHOL POSSESSION, CONSUMPTION AND ADHERENCE TO STATE AND MUNICIPAL LAWS.
  - c) ALL OTHER PROCEDURES PRESENTED BY THE COMMUNITY HOSPITAL – COLORADO WEST HEALTHCARE SYSTEM WILL BE FOLLOWED.
- 2. DENY THE SPECIAL EVENTS PERMIT.

#### 3. APPROVE THE PERMIT WITH MODIFIED CONDITIONS.
