#### **BACKGROUND**

The purpose for this workshop is for Economic Planning Systems (EPS) to present initial findings from their housing needs assessment, programmatic elements, and unit shortages related to income. This presentation will be in draft form, with the purpose of receiving feedback from the Council related to findings. The planning team views the findings presentation as a foundational component of exploring any future housing strategies. The EPS presentation will focus on two main components "catch up" and "keep up" which were derived from specific sample housing goals. The establishment of housing goals will necessitate future public engagement where community members can weigh in on objective and measurable outcomes.
