BACKGROUND

Sales, Use Tax and Lodging Tax Revenues – October 2021 Sales.

The following chart provides a comparison of sales, use and lodging tax revenues between 2020 and 2021. Overall tax revenues are up \$1.05 million from the prior year and ahead of budgeted amounts by \$1.34 million.

The following table shows a comparison between October 2020 and 2021 city sales tax collections by NAICS category. Retail trade continues to be the <u>largest dollar contributor</u> to the monthly increase in city sales tax.


Sales tax revenues are up 9% for the month over the same period last year and up 15% year to date. Attached is 5 year history of the year-to-date sales and use tax revenues by Category (NAICS).

Use tax revenues on motor vehicles are up 31% for the month (up 17% for the year) and use tax revenues on building materials are up 100% for the month and up 5% year to date.

Community Center Fund – November 2021.

City sales and use tax revenues for October reflect a 19% increase from 2020 revenues (15% YTD). Sales and use tax revenues collected YTD represent 104% of the 2021 budgeted revenues.

October charges for services (pass fees and recreation programs) are up 80% from the prior year (72% YTD) but down 15% from 2019 pre-covid levels for the month and (23% YTD). However, this compares favorably to the 2021 budgeted revenues which were budgeted at 53% of 2019 pre-covid levels.



<u>Revenue vs Expense by Account Type – November 2021.</u> This report presents summary information on revenues and expenses and budget comparisons for all funds. The report includes revenues and expenses by type and also by department. The following is a summary of the report by fund showing actual revenues and expenses as a percentage of budget.
