Randy Jirkovsky introduced himself as a retired truck driver now living in Fulton, Texas. In his previous profession he transported many materials including hazardous materials. His concern for the

community is that there are hazardous materials being transported through the town. He asked the council research: unplacard #3161, what are the general determinants of unplacard #3161, and what would happen with an unscheduled release of hazardous unplacard #3161. He suggested to the Council that the Town should petition TxDot to reroute these kinds of hazardous materials so that they are not transported on Highway 35.
