The Garden City Police Department responded to forty-seven (47) calls for service in the last year at the Bandido Nightclub. 12 of the incidents have been harassment, assault, or disturbance related and most of the parties have been intoxicated. Bandido has not been linked directly for alcohol related issues at this time as no circumstances that were investigated relate back directly to the bar. There has been a better working relationship with security and bar staff.

There were no concerns during the physical inspection at the bar.

The Garden City Police Department does not object to the request for renewal of the liquor license for this establishment.
