September Notes:

We significantly stepped up our motor vehicle enforcement activities with the help of Governor's Highway Safety funding. This period we increased from 3 traffic stops to 30. Further, we issued 13 tickets (totaling \$2,494 in fines) and issued 30 warnings. The lone arrest in September was for a criminally suspended license.

Calls for service (from the public) remain relatively low.

There are no specific areas of concern to address in October. We will make sure to increase our activities around trick-or-treating activities.
